The Ark of the Covenant

The *will power* of human beings is capable of achieving miracles when it becomes focused and driven by a deep-seated, inner conviction formed by the residual knowledge obtained through past life experiences. Subconscious impressions of latent memories suddenly become activated at critical moments in our lives; when one meets a close friend from a past life, or one walks past a site that had significance in a prior life.

The inspired archeological research of Ron Wyatt (†1933-1999) was likewise driven by his deeply spiritual conviction that the truth of the Bible story could be proven by accurately identifying and dating artifacts from ancient sites where major events in the life of the teacher and healer named 'Jesus' actually took place.



Intuitive events drove the spectacular archeological investigations of Ron Wyatt, who acted from an inner knowledge that he could not entirely explain. He was eventually led to discover *the Ark of the Covenant:*

Ron Wyatt was in Jerusalem in 1978, after having been diving at the Red Sea inspecting a possible site of the crossing by Moses at the Gulf of Aqaba, and was preparing to return to the states, when he was approached by a member of the Israeli Antiquities Authority who invited him to take a walk in the Garden Tomb grounds. While walking through this area, his arm pointed to a pile of trash next to an escarpment and these words came out of his mouth, "*There is Jeremiah's Grotto and the Ark of the Covenant is in there.*"

He hadn't even thought of those words, but they came out through God's direction. The official with Mr. Wyatt said that was wonderful to hear, and he would give Ron a place to stay, and food to eat while working on the site. This was puzzling to Ron because he had not even thought about the Ark, and yet God spoke through him with those words. First, Ron had to return to the states and begin research on the idea of the Ark even being in that location. Over the next three and a half years he worked at the site, and on January 6, 1982, Ron entered the chamber that contained the Ark of the Covenant...¹

There were three large cut-outs in the escarpment wall behind the place where the featured victim, in this case Jesus, was crucified. On January 6, 1982, after years of hard labor and excavation permits issued by the Israeli Department of Antiquities, Ron Wyatt crawled into the cave where the Ark was located. In this cave he also found the Table of Shewbread, the 7-branch [Menorah] lamp stand, the Golden Altar of Incense, and the Golden Censer which all still remain there today. He brought out a very large sword, numerous oil lamps, a brass shekel weight, a brass ring, and an ephod.

Any item Ron would find in the excavation he would turn over to the Israel Antiquities Authority, which he did. Today in the Israel Museum Jerusalem, you can see the ivory pomegranate Ron turned over to the IAA after bringing it out of the tunnel system that led to the cave that houses the Ark of the Covenant. It is said to be the only item ever found from Solomon's temple, in the first temple period. It is a thumb-sized pomegranate believed to have been used by the Temple priests during their ceremonies.



Around the shoulder of the pomegranate is a carefully incised inscription in early Hebrew characters, part of which is broken off, and reads: "qodes kohanim I-beyt [yahwe]h" or "Sacred donation for the priests of (in) the House of [Yahwe]h." "House of Yahweh" most probably refers to the Temple in Jerusalem. It has a hollow cavity in the base for mounting on a rod or shaft. The shaft is now resting in the cave with the ark, placed there by Ron. The pomegranate was a favorite motif in the Temple of Solomon.

After Ron gave this to the IAA in 1979 or 1980, the department was subsequently plundered and many items stolen, including this wonderful find. In 1981 it appeared in a French magazine. Then in 1988, an antiquities dealer in France sold it to the IAA for \$550,000.00, according to the Biblical Archaeology Review. This ivory pomegranate has been featured in many articles, first in 1984, in the Biblical Archaeology Review while in the hands of the French, but no one has ever said where it was found. That is a mystery to most, but we know it was found in the tunnel system during the Ark of the Covenant dig. There is not an official, public dig associated with this find. Ron Wyatt carried two parts of the pomegranate into the cave where the Ark of the Covenant rests. The shaft or rod of the pomegranate was put in the cave as evidence of where it came from, and also one of the leaves, to show folks later that the temple furnishings are associated with the ivory pomegranate.

When Ron first entered the cave, he noticed a dark substance that had dripped out of a crack in the ceiling directly above the Ark, onto the top of a stone sarcophagus, and down inside of it. The Ark was in a large stone sarcophagus and the top or lid of the stone case had been broken and moved aside, allowing the dark substance inside. The dark substance that was on the ceiling had dripped onto the top of the stone case and down inside onto the golden lid or Mercy Seat of the Ark of the Covenant.

It was at this moment that Ron realized the cross hole above communicated down to this cave below via a fissure in the bedrock, and had allowed a dark substance to fall on the Ark. Ron passed out, as he realized that dark substance was the actual blood of Jesus! Ron was unconscious for 45 minutes, exhausted from double pneumonia and hard work. Inside the cave were the other furnishings of the Mosaic tabernacle, including the golden candlestick, the table of showbread, the altar of incense, plus a large sword that may have belonged to Goliath, and other items. Stacked on top of everything were animal skins then boards, then stones.



The cut-outs in the escarpment behind the cross were apparently designed to hold signs relating to the person being executed. In this case they would have said, "Jesus of Nazareth, King of the Jews," in Greek, Hebrew and Latin, and would have been on the cross also, but smaller in size. Surrounding the crucifixion site is the foundation of a first century church, and within this is the 13' diameter rolling stone used to seal the Garden Tomb. The cross hole that was used to crucify Christ has a large crack in the bedrock next to it which extends all the way down under the cross hole to a cave below.

The Ark of the Covenant had been secreted into this cave in 586 BC when the Babylonians had Jerusalem under siege (II Kings 25). Jeremiah and his assistants wished to hide the furnishings of the tabernacle from the pagan invaders. But in reality this was part of God's plan. If the Jews had accepted Christ as the Messiah, the Jews would have had possession of the Ark at the time of Christ and would have offered Jesus' blood as the final sacrifice and would have placed His blood on the vacant western side of the Mercy Seat of the Ark. But God knew they would not accept His Son, so He had His own plan arranged to place the blood of His Son on the Most Holy, the Ark of the Covenant. When Christ died, "the rocks were rent," creating the crack in the bedrock leading down into the cave below.

A Roman soldier speared Christ's left side, causing *blood* and *water* to flow through the crack into the cave below. The lid of the stone case containing the Ark of the Covenant, was broken and moved aside allowing Christ's blood to flow directly onto the Mercy Seat of the Ark. At this moment type met antitype. Both the old and new covenants were ratified by the blood of Jesus. The ceremonial system, which looked forward to Christ's sacrifice, came to an end. At that moment the large, thick veil in the temple was torn by God from top to bottom and the sacrificial Passover lamb escaped, because Jesus was the final sacrifice.



Daniel 9:24 mentions this anointing of the Ark: "Seventy weeks are determined upon thy people (Jews), and upon thy holy city, to... make reconciliation for iniquity, and to bring in everlasting righteousness, and to seal up the vision and prophecy, and to *anoint the Most Holy*." "Most Holy" is Strong's word 6944 qodesh "a sacred place or thing" and is here twice, "qodesh qodesh". But before it we have the word "the", which is the definite article. It is speaking of a place or thing, not a person. These words are used in the Bible in association with the Most Holy Place. Jesus was both the High Priest and sacrifice at his death. His blood anointed the Ark of the Covenant, or Mercy Seat, normally found in the Most Holy Place.

The Jews were given 490 days (70 weeks x 7) and using the day for a year principle (Numbers 14:34, Ezek. 4:6) we know this was actually 490 prophetic years. Starting with Artexerxes decree to rebuild Jerusalem in 457 BC (verse 25), we find that this 490 years ended $3^{1}/_{2}$ years after Jesus' death at the stoning of Stephen marking the end of the Jewish dispensation. The Bible prophesied that Jesus (Messiah the Prince v.25) ministry would begin at 69 weeks at His baptism, then in the middle of the 70th week, after 3.5 years, He would "cause the sacrifice and the oblation to cease" v. 27 or offer his own sacrifice at the crucifixion. The forces of darkness have placed this 70th week in the future where the antichrist would show up, but all that theory does is to ignore the beautiful sacrifice that Jesus did for us on Calvary.

In Mr. Wyatt's fourth trip into the cave in the late 1980's or early 1990's, he dropped down into the cave and immediately felt that he was not alone. As he turned around he could see four men in the cave. They identified themselves as the four angels that had been guarding the ark since Moses put the 10 Commandments inside. He was stunned to see all the rock, boards, and other unnecessary items removed from the cave by these heavenly messengers. The furnishings were placed in their proper configuration in the cave. The cave wall behind the Ark is pure crystal and reflects all the colors of the rainbow. (The heavenly Ark has a rainbow over it.) In the past, Ron had wondered how he would ever open the ark, as this would be a difficult task since the five ft. tall angels and the Mercy Seat were solid gold and would weigh approximately 500 lbs.

Now the angels in the cave asked Ron to position his video camera to film what was to happen next. The four angels lifted up the top of the Ark and said, "Reach in, take the Ten Commandments out. When a world-wide law is enforced forcing men to violate the Law of God, then they will be shown to mankind." Wyatt held the tablets and one of the angels took them and placed them on a shelf in the cave along with the video showing their removal.

The Ten Commandments are on two tablets of stone and have writing on both sides. They are written in Proto-Aramaic Mr. Wyatt said in 1999. One of the angels told Ron to take a sample of Christ's blood and have it analyzed. From what Ron said, the angel told Ron steps that should be taken by the lab experts to reconstitute the blood, place it in a growth medium, and analyze the chromosome. Ron did as he was told.

Wyatt removed a sample of Christ's blood from the Mercy Seat of the Ark in the cave and paid a lab in Israel to do an analysis of the blood. They put the dark, dried-out substance in saline solution for 72 hours, then added a growth medium to the blood for 48 hours. Ron asked them to do a chromosome test, but they informed him that he was wasting his money since you can't do a chromosome test on dead white blood cells. They proceeded with the analysis and said, "It's your money." As they began viewing the cells under the microscope, they saw cells dividing before their eyes! They could tell it was human blood, but [exclaimed excitedly:] "This blood is *alive!*" They couldn't believe what they were seeing!



They continued with their tests and found the blood to be *unique* from any other human blood! Each cell contained *only 24 chromosomes* compared to the normal count of 46 that you and I have. Christ received 23 chromosomes from Mary, and one 'y' chromosome from His heavenly Father to designate a male child. Others in the lab were asked to come see for themselves. With tears in their eyes they asked, "Whose blood is this?" Mr. Wyatt replied, "It is the blood of your Messiah." Then they asked who the Messiah was, and they began wailing and shouting. No other male human being has ever had this same chromosome count! Christ's blood is *alive* and *unique* to prove His divinity to the world before He returns to this Earth. When these tests are repeated for all-the-world to see, everyone will learn that Jesus was more than a preacher, He *was* and *is* the Son of God!²

There can be no doubt that the spiritually inspired and dedicated archeological research of Ron Wyatt –both in Turkey and in Israel– has significantly strengthened the faith of many Christians in all parts of the world; those who have heard the news and recognized the great importance of his many discoveries. The facts of the case clearly indicate Ron was 'chosen' and telepathically influenced to succeed in his excavation work.

Wyatt's work was accomplished with the coordinated effort of many assistants, and especially 4 'Guardian Angels' of the Ark that instructed him at every step of the process. Interference was severely punished by the overseeing Angels; *one man was hospitalized and 16 others were killed on site by invisible forces* during their attempted trespasses. Ron was even asked to remove 6 bodies from a tunnel no one else would enter!

Detailed accounts confirm Ron Wyatt's investigations were propelled by a sequence of highly improbable events that were apparently guided by *unseen ET forces monitoring from high above using cloaked drones.*

The series of orchestrated events extends back nearly 2,600 years to the evacuation of the Ark from the besieged First Temple into the hidden storage chamber –situated directly below the future crucifixion site. At the final stage of the crucifixion, after Jesus had fallen unconscious, infrasonic wave focusing was used to split the bedrock cliff near Calvary Hill *through the crucifix hole to the Ark of the Covenant:* "And, behold, the veil of the temple was rent in two…; and the earth did quake, and the rocks rent…" (Matthew 27-51).



These prophesied events brought an end to the longstanding religious practice of ritual animal sacrifice by His people. Ritual anointment of the Ark with blood of a lamb was replaced by the permanent offering of the living blood of Christ deposited on the Ark, "to seal up the vision and prophecy, to anoint the Most Holy."

'Anointment' of the Ark of the Covenant with the sacrificial blood of Christ was directed by Angelic forces, who focused acoustic waves to split the rock face, allowing His blood to pool on the golden Ark concealed below. Four Angels also met and instructed Ron Wyatt on procedures for revitalizing the living blood sample, specifying tests and examinations to reveal the chromosomal profile of the individual. Successful completion of these scientific protocols shows agreement of the testimony of the spirit, the water and the blood:



This is the one who came by water and blood –Jesus Christ. He did not come by water only, but by water and blood. And it is the Spirit who testifies, because the Spirit is the truth. For there are three that testify: the Spirit, the water and the blood; and the three are in agreement. We accept human testimony, but God's testimony is greater because it is the testimony of God, which he has given about his Son. Whoever believes in the Son of God accepts this testimony. (1 John 5:10)

While official laboratory test results pertaining to chromosome counts –*obtained from cultured white blood cells extracted from the living blood of Christ*– have been entirely withheld from the general public, clear statements made in the Bible reinforce the surprising eyewitness account given by Ron Wyatt himself. The blood sample was obtained from a small dried pool that had collected on a stone directly above the crack through which it flowed down 20' onto the mercy seat of the Ark, in Jeremiah's Cave (2 Maccabees 2:5–8):



Jeremiah came and found a cave-dwelling, and he brought there the tent and the ark and the altar of incense; then he sealed up the entrance. Some of those who followed him came up intending to mark the way, but could not find it. When Jeremiah learned of it, he rebuked them and declared: "The place shall remain unknown until God gathers his people together again and shows his mercy. Then the Lord will disclose these things, and the glory of the Lord and the cloud will appear, as they were shown in the case of Moses, and as Solomon asked that the place should be specially consecrated."



Just prior to the destruction of Solomon's Temple by the Babylonian siege of 587 BC, sudden evacuation of the Ark of the Covenant was accomplished by High Priest Jeremiah with the help of several other temple priests through quarry caverns located below Mount Moriah, connecting to Zedekiah's Cave (overleaf) and eventually leading into the small hidden chamber referenced ever since the event as 'Jeremiah's Grotto'.



Wyatt could not find an entrance to the cave tunnel network, and was determined to enter by drilling through what he thought was the natural bedrock face itself. In fact, this wall was a geopolymer façade that proved to be only 8" thick, that was the result of the work of Jeremiah to hide the entrance to the tunnels. Natural meleke limestone bedrock of Mount Moriah was quarried here in ancient times to form this system (above).



Geopolymer imitation stalactite Jeremiah's Grotto, Calvary Hill

Concealment work by Jeremiah and his assistants involved cement-like applications of synthetic limestone, now referred to as geopolymer limestone. Strong evidence for this claim was collected during entry excavations by Ron Wyatt in 1982, when he broke off what appeared to be a large stalactite hanging immediately in front of the narrow passageway, directly blocking entry into Jeremiah's Grotto (above).

This unusual formation was not natural, but was made specifically as a marker and protector of the small entryway to Jeremiah's Grotto, which could not have been bypassed without being broken off from the roof of the passage. All other access points to the small chamber had been carefully sealed off with geopolymer limestone that was more durable than the underlying bedrock, leaving the false stalactite.

This geopolymer stone imitation of a naturally formed stalactite was collected by Ron Wyatt for study, and remains in his archeological collection to this day.³ Thermoluminescence and other dating methods can be applied to this limestone sample to determine its origin; man-made or natural. Geologists teach us that the specimen's size indicates a minimum age of several thousand years, given the extremely arid conditions of the region of origin. Formation of a large stalactite leaves a stalagmite directly below, *yet none was found*. Also, *no other stalactites of any size* were found or collected during Wyatt's excavations below Calvary Hill.



Artificial stone may also have been used to construct Jacob's well at Shechem (at left), where the Master shared knowledge of living water with a Samaritan woman (John 4:5-14):

So he came to a town of Samaria called Sychar, near the field that Jacob had given to his son Joseph. Jacob's well was there; so Jesus, wearied as he was from his journey, was sitting beside the well. It was about the sixth hour. A woman from Samaria came to draw water. Jesus said to her, "Give me a drink." (For his disciples had gone away into the city to buy food.)

The Samaritan woman said to him, "How is it that you, a Jew, ask for a drink from me, a woman of Samaria?" (For Jews have no dealings with Samaritans.) Jesus answered her, "If you knew the gift of God, and who it is that is saying to you, 'Give me a drink,' you would have asked him, and he would have given you living water." The woman said to him, "Sir, you have nothing to draw water with, and the well is deep [120 feet, 40 m.]. Where do you get that living water? Are you greater than our father Jacob? He gave us the well and drank from it himself. as did his sons and his livestock." Jesus said to her, "Everyone who drinks of this water will be thirsty again, but whoever drinks of the water that I will give him will never be thirsty again. The water that I will give him will become in him a spring of water welling up to eternal life."

Precious words from the Master were not entirely understood at that time –not by the woman herself, nor any listener or reader of the Bible since. There is a single, specific explanation for the sacred meaning of the concept shared by Jesus –one that only an alchemist would recognize. The "spring of water welling up to eternal life" is a direct reference to *hydrogen atoms released by circulation of the blood and capillaries*, whereby the phonon vibrations of oxygen induce resonant atomic transmutation of blood metals at 37.8°C.⁴

The vitalizing function of the Ark of the Covenant *–used to preserve blood in its living state for >2,500 years–* is the result of a special gold alloy used in its fabrication, which must have included a hard, *highly radioactive* metal with an extremely long half-life. Preservative effects of the Ark are the result of high-intensity α -decay radiations of metastable moscovium isotope Mc²⁹⁶. When the Ark was not housed in Solomon's Temple, it was kept in the Wilderness Tabernacle, a large portable temple with a tent city (3D reconstructions, overleaf):





The construction of the Ark is commanded by God to Moses while the Jews were still camped at Sinai (Ex. 25:10-22; 37:1-9). The Ark was a box with the dimensions of two-and-a-half cubits in length, by one-and-a-half cubits in height, by one-and-a-half cubits in width (a cubit is about 18 inches). It was constructed of acacia wood, and was plated with pure gold, inside and out. On the bottom of the box, four gold rings were attached, through which two poles, also made of acacia and coated in gold, were put. The family of Kehath, of the tribe of Levi, would carry the Ark on their shoulders using these poles...

The Ark was built by Bezalel, son of Uri, son of Hur, who constructed the entire Tabernacle – the portable Temple used in the desert and during the conquest of the land of Israel. The Tabernacle was the resting place for the Ark, and also contained other vessels that were used in the physical worship of God. The Biblical commentators argue over why God commanded Moses to build a Tabernacle in the first place: According to Rashi (Ex. 31:18), God realized after the sin of the Golden Calf that the Israelites needed an outlet for physical worship, and commanded that they build the Tabernacle as a way of expressing their own need for physical representation of God...



Spiritually, the Ark was the manifestation of God's physical presence on Earth (the shekhina). When God spoke with Moses in the Tent of Meeting in the desert, he did so from between the two Cherubs (*Num.* 7:89). Once the Ark was moved into the Holy of Holies in the Tabernacle, and later in the Temple, it was accessible only once a year, and then, only by one person. On Yom Kippur, the High Priest (*Kohen Gadol*) could enter the Holy of Holies to ask forgiveness for himself and for all the nation of Israel (*Lev.* 16:2).

The relationship between the Ark and the *shekhina* is reinforced by the recurring motif of clouds. God's presence is frequently seen in the guise of a cloud in the Bible (*Ex.* 24:16), and the Ark is constantly accompanied by clouds: When God spoke from between the Cherubs, there was a glowing cloud visible there (*Ex.* 40:35); when the Jews traveled, they were led by the Ark and a pillar of clouds (*Num.* 10:34); at night, the pillar of clouds was replaced by a pillar of fire, another common descriptor of God's appearance (*Ex.* 24:17); and when the High Priest entered presence of the Ark on Yom Kippur, he did so only under the cover of a cloud of incense, perhaps intended to mask the sight of the shekhina in all its glory (*Lev.* 16:13).

The holiness of the Ark also made it dangerous to those who came in contact with it. When Nadav and Avihu, sons of Aaron, brought a foreign flame to offer a sacrifice in the Tabernacle, they were devoured by a fire that emanated "from the Lord" (*Lev.* 10:2). During the saga of the capture of the Ark by the Philistines, numerous people, including some who merely looked at the Ark, were killed by its power. Similarly, Priests who served in the Tabernacle and Temple were told that viewing the Ark at an improper time would result in immediate death (*Num.* 4:20).

The Ark accompanied the Jews throughout their time in the desert, traveling with them and accompanying them to the wars with Emor and Midian. When the Jews crossed into the land of Canaan, the waters of the Jordan River miraculously split and the Ark led them through (*Josh.* 3). Throughout their conquest of the land, the Jews were accompanied by the Ark. The most dramatic demonstration of its power comes when the Jews breached the walls of Jericho merely by circling them, blowing horns and carrying the Ark (*Josh.* 6).

After the conquest was completed, the Ark, and the entire Tabernacle, were set up in Shiloh (*Josh.* 18). There they remained until the battles of the Jews with the Philistines during the Priesthood of Eli... The Philistines took the Ark back to Ashdod, their capital city in the south of Canaan,... and soon afterward, the entire city of Ashdod was struck with a plague. The Philistines moved the Ark to the city of Gath, and from there to Ekron, but whatever city the Ark was in, the inhabitants were struck with plague. After seven months, the Philistines decided to send the Ark back to the Israelites, and accompanied it with expensive gifts. The Ark was taken back to Beit Shemesh, and,... men of Beit Shemesh were punished for staring disrespectfully at the Ark, and many were killed with a plague.



From Beit Shemesh, the Ark was transported to Kiryat Yearim, where it remained for twenty years. From there, King David transported it to Jerusalem. En route, however, the oxen pulling it stumbled, and when Uzzah reached out to steady the Ark, he died immediately.⁵

Scores of deaths resulting from improper use of the Ark of the Covenant were incurred by ignorance of the potentially lethal effects of prolonged exposure to γ -radiations emitted by the special binary alloy composed of gold (Au¹⁹⁷) and moscovium (Mc²⁹⁶). 'Plagues' were actually *radiation sickness*. Historical accounts of events surrounding the Ark of the Covenant suggest the Mc²⁹⁶ alloy component was gifted 'from above'.

An ancient wall represents the remains of the Crucifixion Temple that was part of the building originally constructed by the disciples of Jesus after his crucifixion and spectacular resurrection. Coins from 35-50 AD were recovered by archeological excavations there, as well as a large circular platform placed in the center of the building, facing the group of rock-cut crucifix holes. Measuring 2' in thickness and 13.2' in diameter, this perfectly round stone matches the dimensions of the rolling stone of the Garden Tomb, having been rolled to the Crucifixion Temple, where the 12 disciples gathered to worship before their exile in 66 AD.

English documents traced by Jonathan Gray, who assisted in Wyatt's Ark excavation, confirm that Joseph of Arimathea escaped to France and traveled to England.⁶ Joseph had earned his wealth by establishing tin mines in Cornwall for export by his fleet of ships to Judea. These circumstances reveal the actual origin of the legend of King Arthur and the 12 'Knights of the Round Table', which is based on the ~35-year period during which Christ's 12 disciples worshipped around the huge rolling stone within the Crucifixion Temple.

In 1982, Wyatt produced a documentary video of the Ark of the Covenant, the bloodstain and the crack in the roof of the small chamber below Jeremiah's Grotto. The video has only been viewed by a select few:

Personal Testimony by Ian Thain: This may be an appropriate time to mention publicly that I and several other Christians have watched with our own eyes a video which Ron shot inside the cave before the furniture was rearranged. The crack in the roof was clearly visible with the blood still on it; the table was there in close-up, and many piles of skins. The Ark was there, but was covered by a brilliant white light, which hid it from the camera as Ron panned around the cave.

To the best of my knowledge there is only one copy of it in existence, Ron's original, and it's not in America now. It's in a safe place of the Lord's own choosing to which I once took Aaron Sen, who has met the keeper but has not viewed the tape. I was an eyewitness of Ron's tape of the inside of the cave. I wasn't with him when he shot it, but I saw the tape not very long afterwards. Ron himself was keen that the tape should be seen widely. Events turned out otherwise however.

But for what it's worth I'm happy to answer any questions I can about the tape, and what I saw on it. I last viewed it some years ago and my visual memory is not great (I'm far better with words). However by the same token my visual imagination is pretty bad too, which is probably a good thing for this purpose.

Q: How long is the videotape? A: The section shot inside the cave was part of a longer tape, most of which contained other less dramatic stuff. I'd say there were several minutes of material shot inside the cave.



Q: What quality is it? Shaky? Steady? On a tripod? In color? A: Steady and in color. From what I can recall I'd say it was almost certainly shot using a tripod and a single camera light, which Ron moved about in between shots from one part of the cave to another so as to get pictures of the contents from different angles...

Q: What does the Table of Showbread look like? A: To be honest it looked dark bronze [color], but I suppose that was the effect of the camera light which probably had a predominantly blue spectrum. The table was rectangular and had a raised decorative border a few inches high running all around the top, with what I took to be cast pomegranates at regular intervals. The cave sequence opened with a close-up shot of one corner of the table, showing some fine workmanship in its making...

Q: You... saw the skins piled up in a corner? A: They weren't piled in a corner; they were heaped everywhere, all over the floor and everything else. Lots of them... They were folded up as you would fold a lot of blankets, and some were obviously covering large objects underneath. The menorah may have been on its side under them.

Q: Did you see any other object in the cave and if so what were they? A: At the time I thought that this tape was going on general release and that I'd be getting a copy sometime, so I didn't make any mental notes. But I do remember seeing the stone box in which the Ark had been stored, with its lid moved to one side.

I have a feeling that Goliath's sword was there, but I have no particular mental image of it; just that we discussed it between ourselves, and the reason for our discussing it was probably that it was in there. Of course the dominant feature was the Ark itself, and the fact that it was hidden by a brilliant white light.

As Ron panned the camera around, a circle of light moved across the field of view until it filled the whole screen, then it moved off again at the other edge. Ron's verbal account of this was that the effect was only on the tape; no such light was visible to him inside the cave where he saw the Ark plainly. It was only when he viewed the tape afterwards that he saw that the light had covered the Ark for the purpose of the recording.

The other notable feature was the crack in the roof of the cave with the dark stain of blood on one side of it, about the size of one's hand I should think. (The roof was not high; a man would probably have had to stoop to avoid hitting his head). Seeing the blood there was the most moving thing to me.⁷

This eyewitness account of *video footage* of the secret chamber of artifacts included the Ark of the Covenant. The same surprising energetic phenomena apparently obscured photographs taken by Polaroid and 35 mm camera films exposed to the Ark, causing the complete blurring of images in every case.

Immediately after looking down into the black stone box to identify the object as the Ark, Ron Wyatt fell unconscious. He remained unconscious for approximately 20 minutes, before regaining awareness at about 2:45pm, which he confirmed by checking his wristwatch. *What had caused this lapse of consciousness?*

Ron attributed his passing out to the utter shock of the astonishing discovery of the Ark, yet the greater significance of this event has not been recognized until the present. The abundance of evidence presented here confirms that Wyatt lost consciousness due to his close proximity to the Ark, resulting in exposure of his head to the Ark metals' powerful γ -ray emissions *–confirming the presence of moscovium* (Mc²⁹⁶).⁸ The same surprising psycho-spiritual effect has been described in the sublime teachings of Siddha Bokar, which were attributed to the proper use of *svarupa* kuligai, whereby the body obtains quantum capacities:



I will start with *svarupa kuligai*! This will make a person invisible as soon as he/she wishes for it! If one keeps this svarupa kuligai in his/her mouth, he/she will get the form of the flame in a lighted lamp. Even if one stabs the person in anger, or pierces with a sword right in the middle of the head, the body will rejoin, and when he/she becomes invisible, the anger will also disappear!

Everything will disappear. One's mind will cease when he/she is putting this kuligai in his/her mouth. As soon as they turn invisible, the lost senses will be back! If the kuligai doesn't suit, the senses won't become altered! Artificial fragrances turn void, and the body will disappear by getting into a round shape! This is the nature of a pure kuligai! (Bogar 7000: 539-540)⁹

As surprising as the explanations of Bokar may seem, exactly the same scenario was directly described by trance medium Edgar Cayce as a 'rolling back' of the conscious mind to delve far below (Reading 364-10):

When there is a manifestation of a psychic force, or an occult action, or phenomena, or activity in, upon, of or for, an individual, there is then the rolling back, as it were, or a portion of the physical consciousness –or that mental trained individual consciousness– has been rolled aside, or rolled back, and there is then a visioning. To what?

That as from the beginning, a projection *of* that form that assumed its position or condition in the Earth as from the beginning, and with those so endowed with that as may be called an insight into psychic sources there may be visioned about a body its astral (if chosen to be termed), rather its thought body, as is projected from same in such a state; especially so when there is the induction, or the inducing of, an unconsciousness of the normal brain, or normal mental body. Submerged –into what? Into the unconscious, or subconscious.

These complex explanations offered through Cayce pertain to the powerful yet invisible energetic effects of γ -rays, closely echoing the statements of Siddha Bokar describing applications of kuligai amalgam beads. The congruent explanations from these two high-level sources are reinforced by imagery on the Ark itself.

The ornate workmanship of the Ark of the Covenant employs special symbolic representations that have not been properly recognized until the present time, providing unmistakable references that confirm the invisible function of the Ark of the Covenant as a powerful γ -radiation emitter for illuminating the qi meridian system of the human body *through the activation of ingested photoluminescent mineral nanopowders*.

The pomegranate has long been used as a sacred symbol representing fecundity, as it contains in its perfectly round fruit a multitude of seeds. In Roman times, the pomegranate was a fruit dedicated to Juno, goddess of marriage and fertility. Several representations of Venus, goddess of beauty, have been found in Sardinia where she holds a pomegranate that is opened. A similar meaning is at work in the custom in China of offering pomegranates as an engagement gift. They were an omen of good luck for having children.

Ancient books identify the pomegranate tree root as a powerful *vermifuge*; an agent that destroys or expels parasitic worms. The mystics of the Middle Age compared the intestinal worms to inner demons, and, as such, gave pomegranate roots the symbolism of fighting the evil within one self and expelling it.



The pomegranate has only recently been recognized for neuroprotective effects and promoting radiation recovery –qualities that were apparently very well known to the ancient healers and priests of Aramaia:

Phytochemicals, including the phenols, terpenes, and organosulfurs, are nonnutritive, bioactive compounds commonly found in plants and animals and are known for their protective properties. Phytochemicals not only protect the plants that produce them against metabolic and environmental disease but also, when consumed, can provide numerous health benefits to humans.

Foods containing phytochemicals have been shown to ameliorate cognitive and behavioral deficits resulting from various diseases. These findings have often been attributed to the antioxidant, antiapoptotic, and anti-inflammatory properties of phytochemicals. Some fruits, for example, contain polyphenols that can impart extensive protective properties against damage from oxidative stress, neuroinflammation, and cognitive/behavioral deficits induced by radiation and/or aging.

Pomegranates (Punica *granatum*) have a high polyphenol concentration, and the juice may have 2-3 times greater antioxidant capacity compared to other antioxidant sources such as red wine or green tea. Pomegranate polyphenols include flavonoids (ie., quercetin) and tannins (ie., punicalagins and ellagitannins). Flavonoids and tannins have specifically been shown to decrease oxidative stress by deactivating reactive oxygen species and scavenging free radicals.

Although these isolated pomegranate polyphenols have antioxidant properties when acting individually, research suggests that the whole range of polyphenols found in pomegranates combines synergistically to prevent oxidative stress-induced damage. Indeed, one study analyzing the antiapoptotic properties of pomegranate juice found the whole juice to be more effective than any one isolated component. Furthermore, pomegranate juice has been found to ameliorate both amyloid plaque load as well as associated spatial learning deficits in a mouse model for Alzheimer's disease.

Altogether, this evidence suggests that the polyphenols found in pomegranates could provide an effective therapy against radiation-induced neurological and cognitive/behavioral deficits. No studies to date have looked at the radioprotective effects of pomegranate antioxidants; however, the evidence indicates that antioxidants may be beneficial in ameliorating the negative effects of ionizing radiation. Therefore, this study explores the putative protective effects of pomegranate juice on radiation-induced cognitive and behavioral deficits...



Pomegranates may protect the brain (and therefore behavior) from the effects of radiation by a number of potential mechanisms. Particles can strike DNA, causing damage and apoptosis. Particles can also strike water molecules, generating reactive oxidative species that cause inflammation, vascular damage, and suppressed neurogenesis. Pomegranate's neuroprotective, antioxidant, anti-inflammatory, and provascular (via nitric oxide synthase) properties may protect against these effects.

Our findings suggest that pomegranate therapy may provide protection against radiation-induced changes in affective behaviors, and some of these effects may be gender specific. Furthermore, pomegranates may provide gender specific benefits to sensorimotor coordination. Our findings thus highlight the importance of understanding gender differences in the effects of radiation as well as pomegranate treatment. Women have been part of the space program since its inception and comprise 11% of the astronauts who have flown in space.

Previous research has demonstrated that radiation affects males and females somewhat differently; specific health issues for space travel highlight gender differences in bone loss, orthostatic response, and disease risk, indicating differential effects of the space environment on men and women. Altogether, pomegranate consumption seems to induce beneficial effects, and the possible underlying mechanisms should be explored to better understand their putative benefits.¹⁰

These findings show the natural benefits of pomegranate juice provide significant mitigation of γ -radiation exposure received by astronauts venturing into space, reflecting ancient knowledge expressed in the design motifs of the Ark of the Covenant. There can be no doubt that temple high priests who designed the Ark wore gold plates covering their chests and foreheads when in proximity to the Ark's powerful radiations, and *drank pomegranate juice to protect themselves and aid in their recovery from high radiation exposure*.

The sophisticated use radioactive alloys has been well documented among Atlantean and Siddha alchemy practices, employing radium for ingestion and synthetic moscovium isotope Mc^{296} for gold-based alloys. The biological effects of low-dose γ -radiation excitation have surprised researchers from multiple groups:

Although many studies have looked at the behavioral and cognitive performance deficits following irradiation, only a few papers have explored the neuronal modifications at the synaptic and individual neuronal level. Even fewer have tried to examine how the anatomical changes correspond to the neuronal responses by combining immunochemical and electrophysiological investigations.

The electrophysiological results presented here do not demonstrate any major changes for PS responses at any post-irradiation time point. Exposure to 60 Gy of irradiation had very little effect on synaptic transmission, neuronal excitability, or synaptic inhibition. Radiation also did not appear to alter GABAA tonic or GABAA fast inhibition, but produced a statistically significant reduction in synaptic inhibition seen at 100 ms, indicating a selective depression of GABAA slow inhibition. This was also evident in the reduction in the PPI values seen in irradiated rats. Overall, these were relatively minor effects and are consistent with earlier studies suggesting that gamma radiation has only minor and transient effects on brain tissue at clinically relevant doses (<60 Gy).

For example, a study looking at hippocampal neuron numbers showed that they remained unchanged one year after a rat was exposed to fractionated whole brain irradiation at a dose of 45 Gy applied twice a week for 4.5 weeks. Although the magnitude of effects was relatively low, it could still have a physiological effect and can potentially be clinically meaningful. This idea of neuromodulation by changing neuronal behavior without affecting the physiological integrity of neuronal tissue has been of great interest to groups trying to use focally directed SRS to treat patients with various clinical disorders. This review paper, discussing a collection of studies looking at localized irradiation bringing treatment to patients suffering from such ailments as trigeminal neuralgia and epilepsy, proposes that these minimal and mainly safe changes observed in radiomodulation can play a therapeutic role for other functional and behavioral disorders.

The results presented in this paper showed that following gamma radiation treatments, there were no physicallyevident pathological effects; however, a subtle functional depression in circuit level inhibition was evident. The reduced expression of NPY interneurons could help account for this functional depression, since NPY interneurons are known to be GABAergic and mediate GABAA slow inhibition. It is unlikely that irradiation harmed NPY interneurons, since the effect occurred too soon for this, but it is more likely that a reduction in NPY expression occurred. This change, although temporary (24 hr group), could contribute to antidepressant effects of radiation. In fact it may give us a glimpse into how radiation works in a clinical setting for use as a treatment for patients with functional conditions including major depressive disorder. Similar to observations in our study, antidepressants produce a statistically significant depression of GABAA slow-mediated inhibition in the rat hippocampus. [Our research team found that] radiomodulation of neuronal circuitry was evident as a small but statistically significant decrease in GABA-mediated slow synaptic inhibition.¹¹

These enigmatic findings concerning a measurable neural excitation induced by low-dose exposure to γ -radiation were subsequently reported by another research group in 2022, focusing on metabolic effects:

While the reduction in spontaneous activity at high doses of 60 Gy and beyond might be expected, the disinhibitory effect of irradiation with 40 Gy, both regarding the spontaneous activity and the VEP peak time was surprising. The cellular assay, while not directly translatable to the in vivo situation in terms of absolute doses, may provide evidence on the cellular underpinnings of the disinhibitory effect. The reported higher sensitivity of interneurons is indeed in line with one earlier study, demonstrating that inhibitory cells are more sensitive to injury. Earlier studies have shown that irradiation could affect GABA receptors and GABAergic inhibition, and further modulate the development and function of the central nervous system...

On the receptor level, Kuznetsov et al. (1989) studied the effect of ionizing radiation on the binding of muscimol (a GABA agonist) by synaptic membranes in the cortex of rat brains. 2 Gy was shown to reduce muscimol binding, suggesting GABAergic effects ensuing from the radiation. Daynac et al. (2013) noted in mouse brains that quiescent neural stem cells in the subventricular zone exited dormancy in response to changes in GABAA receptor signaling 2 days following irradiation at 4 Gy. Increases in glial fibrillary acidic protein immunoreactivity, tyrosine hydroxylase, serotonin transporter, and the GluR1 subunit of the alpha-amino-3-hydroxy-5-methyl-4-isoxazole propionate glutamate receptor in penumbral regions of the lesion were found and suggested to be of compensatory neuronal adaptations.

In a functional PET study, again on minipig receiving focal irradiation, doses around 40 Gy led to an increase of local metabolism, contrasted with a decrease of local metabolism of 60 Gy or higher. Together, there is a growing body of evidence suggesting that low doses of irradiation may indeed be capable of increasing the local excitability, reaching a new stable set point... The present study builds upon our early understanding of ionizing radiation-mediated neuromodulation effects and their neurophysiological basis. These principles could, in the future, lead to therapies for brain circuit-based disorders, achieving resilient neuronal networks.¹²

Counter-intuitive findings reported by this research group highlight the beneficial effects of low-dose γ -radiation resulting from GABA-mediated effects that include neural excitation and metabolic stimulation. This work also provides a viable explanation for the many odd assertions made by the Akashic Source speaking through the early 20th century trance medium Edgar Cayce.

In several Life Readings, Cayce expounded on the subject of eating food for spiritual development and the enhancement of vital physiological energies. Certainly, humans living in the 21st century possess a longer average life expectancy than at the time of Edgar Cayce 100 years ago, but his readings seem to indicate that a healthy human lifespan would extend far beyond the current longevity standard (Reading 244-2):

Now, we find there are many changes in the body since we have had this – many for good. Many of the organs and the conditions show the changes as come about by the natural, or so called natural conditions in changes as the body succumbs to the effects of age or usage in the system. Much of this may be overcome. (Man should live much longer than has been ordinarily given –and will!)



Protection of the body's organs by regenerative processes is significantly enhanced by the ingestion of ancient Siddha formulations composed of photoluminescent compounds, including radium sulfide (RaS):

When a 52-year-old construction engineer asked about this expanding consciousness in 1942, Cayce commented that each individual had to essentially work with personal soul development in order to resonate to that new consciousness: "You expect a new root race. What are you doing to prepare for it? You must prepare food for their bodies as well as their minds and their spiritual development!" (Reading 470-35)

Q: What was the greatest period of the development of the occult sciences in Atlantis and how did the people use them? A: This, as we will find, will require a great deal of an explanation even to bring to the consciousness of an individual, in the present day way of thinking, as to what is meant by occult or mystic science; for the natural trend –or the natural condition of individuals, or entities– was the use of these; as it is natural to eat! (Reading 364-9)

These statements seem quite vague, yet directly reference bananas as a γ -emission source of K⁴⁰ isotope. On April 28, 1932, Edgar Cayce gave a pair of astonishing psychic readings on the arcane subject of the psychic or occult science of Atlantis¹³, providing complete explanations in context (Readings 364-9, -10):

EC: In understanding, then, in the present terminology, occult science, or psychic science –as seen, this was the natural or nature's activity in that experience, and not termed a science– any more than would be the desire for food by a new born babe. Rather the natural consequence. This explanation may of necessity take on some forms that may possibly be confusing at times, but illustrations may be made through the various types of occult science, or psychic manifestations, that may clarify for the student something of the various types of psychic manifestations in the present, as well as that that was natural in this period...

From that which has been given, it is seen that individuals in the beginning were more of thought forms than individual entities with personalities as seen in the present, and their projections into the realms of fields of thought that pertain to a developing or evolving world of matter, with the varied presentations about same, of the expressions or attributes in the various things about the entity or individual, or body, through which such science - as termed now, or such phenomena as would be termed –became manifest. Hence we find occult or psychic science was rather the natural state of man in the beginning. Very much as (in illustration) when a baby, or babe, is born into the world and its appetite is first satisfied, and it lies sleeping. Of what is its dreams? That it expects to be, or that it has been? Of what are thoughts? That which is to be, or that which has been, or that which is? Now remember we are speaking –these were thought forms, and we are finding again the illustrations of same!



When the... mental body, or mind, has had training, or has gone through a course of operations in certain directions, such individuals are called so-and-so minded; as one of an inventive turn, and trained; one of a statistician turn, and trained; one of a theologian turn, and trained; one of philosophical turn, and trained. Of what does the mind build? We have turned, then, to that that has become very material, for the mind constantly trained makes for itself *mental* pictures, or makes for that as is reasoned with from its own present dimensional viewpoints –but the babe, from whence its reasoning? from whence its dream?

From that which has been taken in, or that that has been its experience from whence it came? Oft has it been said, and rightly, with a babe's smile 'Dreaming of angels', and close in touch with them –but what has produced that dream? The contact with that upon which it has fed! Don't forget our premise now from which we are reasoning! and we will find that we will have the premise from which those individuals, or the entities, reasoned within the beginning in this land. (We are speaking of Atlanteans, when they became as thought forces.)

From whence did they reason? From the Creative Forces from which they had received their impetus, but acted upon by the thought forms as were in material forms about them, and given that power (will) to be one with that from what it sprang or was given its impetus, or force, yet with the ability to *use* that in the way that seemed, or seemeth, good or well, or pleasing, unto itself. Hence we find in this particular moulding or formative stage, that in which there was the greater development of, and use of, that as is termed or called psychic and occult forces, or science –in the present terminology, or age.

Illustrating, then, that as to how this was used by those entities, those beings, in the formative stage of their experience or sojourn among that as had been created in all of its splendor to supply every want or desire that might be called forth by that being, with all of its attributes physical, mental and spiritual at hand; for, as has been given, even unto the four hundred thousandth generation from the first creation was it prepared for man's indwelling. As we today (turn to today), we find there the developments of those resources.

How long have they remained? Since the beginning! How long has man been able to use them for his undoing, or his pleasure, or for his regeneration? Since the knowledge of some source has awakened within its psychic force, or source, of the apparatus, or the form that it takes, either in a physical or mental (for remember, Mind is the Builder –and it moves along those channels through which, and by which, it may bring into existence in whatever dimension or sphere from which it is reasoning)– and as these may be illustrated in the present:

When there is a manifestation of a psychic force, or an occult action, or phenomena, or activity in, upon, of or for, an individual, there is then the rolling back, as it were, or a portion of the physical consciousness –or that mental trained individual consciousness – has been rolled aside, or rolled back, and there is then a visioning. To what?

That as from the beginning, a projection *of* that form that assumed its position or condition in the Earth as from the beginning, and with those so endowed with that as may be called an insight into psychic sources there may be visioned about a body its astral (if chosen to be termed), rather its thought body, as is projected from same in such a state; especially so when there is the induction, or the inducing of, an unconsciousness of the normal brain, or normal mental body.

Submerged –into what? Into the unconscious, or subconscious. Sub-, in this instance, meaning below –not above normal; below– subjected to the higher consciousness, or to the higher thought, that has been builded –just as sure as has a physical body been builded, from what? That as has been given from its first nucleus as passed through in its experience.

Then there may be visioned by such a body, as may be called with the second sight, or with a vision, that accompanying thought body of such an one, manifesting in much the way and manner as individuals in the Atlantean period of psychic and occult development brought about in their experience. Through such projections there came about that first necessity of the division of the body, to conform to those necessities of that as seen in its own mental vision as builded (mental now –Don't confuse these terms, or else you will become very confused in what is being given!).

The mental vision by its action upon what body is being builded? On the mental body of the individual in a material world, out of Spirit, out of the ability to have all the attributes of the spiritual or unseen forces –but materialized forces, as is necessary from the mental body in a material world mentally trained to, or in, certain directions, or given directions, or following the natural bent of its threefold or threeply body, as is seen in every individual or every entity. As these projected themselves, then we find these developments were in this portion of the development in the Atlantean period.

How were these used? In much as were from the beginning. Remember there was ever the instruction to those peoples that were to hold to that that would bring for the spiritual forces, rather than the abuses of the abilities –as those with familiar spirits, as those that spoke to or partook of the divinations of those that had passed from the Earth's plane, or those that partook of the animal magnetism– that came from the universal consciousness of animal matter as passed into its experience, in its interchange through those periods of integration and disintegration– and the spirit forces possessing those that would lay themselves open to such conditions, for these are as real as physical bodies if the attunements of the entity are such that it may vision them! And they are about you always, sure!

These, then, are entities –sure; whether animal or those endowed with the soul– until they pass through those changes –as there ever has been, see? Also there are those that ever make for those channels in the psychic and occult (we are speaking of, through which man –as it reached that stage, or that position that it became farther and farther from its natural sources, through the same character of channel may it communicate with that from which it is a portion of, or the Creative Forces), and hence the terminology arose as 'Good Spirits' and 'Bad Spirits'; for there are those that partake of the Earth, or of the carnal forces, rather than of those forces that are of the spiritual or creative [impulse].

Those that are destructive are of the Earth. Those that are constructive, then, are the good –or the divine and the devilish, bringing for those developments in their various phases. Hence the greater development of that called occult, or psychic forces, during the Atlantean period –and the use of same, and the abuse of same– was during its first thousand years... That brought about those cycles, or those changes.

Hence we have that which has been given through many of the sources of information, or the channels for individuals –and in those, these, the entity– as a voice upon waters, or as the wind that moved among the reeds and harkened, or again as when the morning stars sang together and the sons of God beheld the coming of man into his own, through the various realms as were brought by the magnifying of, or the deteriorating of, the use of those forces and powers as manifested themselves in a material area, or those that partook of carnal to the gratification of that that brought about its continual hardening and less ability to harken back through that from which it came, and partaking more and more *of* that upon which it became an eater of; or, as is seen even in the material forces in the present: We find those that partake of certain elements [but restrict other elements], unless these become very well balanced with all sources of what?

That of which there were the first causes, or nature, or natural, or God's sources or [atomic] forces are. Hence elements [comprising the body can become a source of spiritual energy,] as... in the terminology of the student of the anatomical, physiological, psychological forces... for each are as atoms of power. From what?



That source from which it has drawn its essence; upon what it feeds. Is one feeding, then, its soul? Or is one feeding its body? Or is one feeding that in-between (its mental body) to its own undoing, or to those foolishnesses of the simple things of life? Being able, then, to partake *of* the physical but not a part of same –but more and more feeding upon those sources from which it emanates itself, or of the spiritual life, so that the physical body, the mental body, are attuned to its soul forces, or its soul source, its Creator, its Maker, in such a way as it develops.

What, then, is psychic force? What *is* occult science? A developing of the abilities within each individual that has not lost its sonship, or its relation to its Creator, to live upon –or demonstrate more and more through phenomena of whatever nature from which it takes its source, for that individual activity of that entity itself through the stages of development through which it has passed, and giving of its life source that there may be brought into being that which gives more knowledge of the source from which the entity essence (Isn't a good word, but signifies that intended to be expressed; not elements, not rudiments, but essence of the entity itself, its spirit and soul –its spirit being its portion of the Creator, its soul that of its entity itself, making itself individual, separate entity, that may be one with the Creative Force from which it comes– or which it is! of which it is made up, in its atomic forces, or in its very essence itself!) emanates; and the more this may be manifest, the greater becomes the occult force.

To what uses, then, did these people in this particular period give their efforts, and in what directions were they active? As many almost as there were individuals! For, as we find from the records as are made, to some there was given the power to become the sons of God; others were workers in brass, in iron, in silver, in gold; others were made in music, and the instruments of music.

These, then, we find in the world today... those that are especially gifted in art –in its various forms; and a real artist (as the world looks at it) isn't very much fit for anything else! Yet it is –what?

An expression of its concept of that from which that entity, sprang –through the various stages of its evolution [of consciousness] (if you choose to call it such) in a material world, or that which it fed its soul or its mental being for its development through its varied experiences in a material world. These, then, are but manifestations (occult forces) in individuals who are called geniuses, or gifted in certain directions.

These, then, are the manners in which the entities, those beings, those souls, in the beginning partook of, or developed. Some brought about monstrosities, as those of its (that entity's) association by its projection with its association with beasts of various characters. Hence, [the appearance of] those of the Styx, the satyr, and the like; those of the sea, or mermaid; those of the unicorn, and those of the various forms –these [are] projections of what?



The [projections of the] abilities in the psychic forces, then, of the mental and the soul –doesn't necessarily mean the body, until it's enabled to be brought into being in whatever form it may make its manifestation –which may never be in a material world, or take form in a threedimensional plane as the Earth is; it may remain in a fourth-dimensional –which is an *idea*!

Best definition that ever may be given of fourthdimension is an idea! Where will it project? Anywhere! Where does it arise from? Who knows! Where will it end? Who can tell! It is allinclusive! It has both length, breadth, height and depth –is without beginning and is without ending! Dependent upon that which it may feed for its sustenance, or it may pass into that much as a thought or an *idea*...

In the use of these, then, in this material plane –of these forces– brought about those that made for all manners of the various forms that are used in the material world today. many of them to a much higher development. As those that sought forms of minerals –and being able to be that the mineral was, hence much more capable– in the psychic or occult force, or power –to classify, or make same in its own classifications.

Who classified them? They were from the beginning! They are themselves! They were those necessities as were in the beginning from an all wise Creator! for remember these came, as did that as was to be the keeper of same! The husbandman of the vineyard! Each entity, each individual –today, has its own vineyard to keep, to dress– For who? Its Maker, from whence it came! What is to be the report in thine own life with those abilities, those forces, as may be manifest in self –through its calling upon, through what?

How does prayer reach the throne of mercy or grace, or that from which it emanates? From itself! Through that of crucifying, nullifying, the carnal mind and opening the mental in such a manner that the Spirit of Truth may flow in its psychic sense, or occult force, into the very being, that you may be one with that from which you came! Be thou faithful unto that committed into thy keeping! Life itself is precious! For why? It is of the Maker itself!

That *is* the beginning! The psychic forces, the attunements, the developments, going to that! As did many in that experience. And Enoch walked with God, and he was not for God took him. As was many of those in those first years, in this land, this experience. These in the present, then, do not justly call it science; rather being close to nature. Listen at the birds. Watch the blush of the rose. Listen at the life rising in the tree. These serve their Maker –through what? That psychic force, that is Life itself, in their respective sphere –that were put for the service of man. Learn thine lesson, O' Man, from that about thee!

These explanations from the Akashic Source speaking through Cayce implore our efforts to investigate our natural environment carefully; to recognize the invisible influences of vital forces emanating from atomic transmutation reactions and nuclear decay processes simultaneously occurring in our atmosphere and within all living organisms. This discussion was continued in a reading on April 29, 1932 (Reading 364-11):

EC: As to why, then, each individual must be, and is, the keeper of his own vineyard? For there is, as from the beginning, in each entity that –of the Father, or the First Cause– that enables one to make manifest even in the material world through the attributes of the First Cause, that makes for the manifestation of that power, or force, in a material world. As to what one does with same is an action of the will that entity himself, or herself.

As to occult or psychic science, as called, then –it is, as we have found through some manifestations, that these forces are first recognized in or by the individual. Hence, as has been seen, in the beginning these were the natural expressions of an entity. As there developed more of the individual association with material conditions, and they partook of same in such a manner as to become wholly or in part a portion *of* same, farther –or more hidden, more unseen– has become occult or psychic manifestations. First there were the occasional harking back. Later by dream. Again we find individuals raised in certain sections for specific purposes.

As the cycle has gone about, time and again has there arisen in the Earth those that manifested these forces in a more magnificent, more beneficent, way and manner. And, as has been given, again the time draws near when there shall be seen and known among men, in many places, the manifestations of such forces in the material world; for "As ye have seen him go, so will He return again."

Be thou faithful unto those words He has given while yet with you. Hence it behooves every individual to take cognizance of that force that may manifest in their material lives, even in this material age; for those that become ashamed for His sake –for *that* sake– of that that may manifest (which is as the Spirit's manner of activity) through those many channels that are open to those who will look up, lift up –and these, we find, are often in the lowliest of places and circumstances.

Why? Since these are forces of the Most High, since these supplied –as of old– those secular things in abundance, and were supplied the needs not only of the physical being but of the mental and spiritual also, contributing to those forces as made for the gratification also of that builded in a material world, does it become any wonder that he that shall be abased and remains true shall wear the Crown of Life?

Does it become unreasonable, then, that ye are being chastised for that which has been builded within the material forces of the body itself, that must be tried so as by fire? For the chaff must be burned out! Even as with the use of those sources of information, the abilities to become a portion of those elements that were the creative forces of the compounds or elements within the universal forces, at that period brought about those forces that made for destruction of the land itself, in the attempt to draw that as was in man then back to the knowledge; and these brought about those destructive forces (that are known today) in gases, with that called the Death Ray, that brought from the bowels of the Earth itself –when turned into sources of those destructions to portions of the land.

Man has ever (even as then) when in distress, either mental, spiritual or physical, sought to know his association, his connection, with the divine forces that brought the worlds into being. As these are sought, so does the promise hold true –or that given man from the beginning, "Will ye be my children, I will be thy God!" "Ye turn your face from me, my face is turned from thee", and those things ye have builded in thine own endeavor to make manifest thine own powers bring those certain destructions in the lives of individuals in the present, even as in those first experiences with the use of those powers that are so taboo by the worldly-wise, that are looked upon as old men's tales and women's fables; yet in the strength of such forces do *worlds* come into being! This is what psychic force, and so-called occult science, *did* mean, has meant, does mean in the world today...

Q: Describe in more detail the causes and effects of the destruction of the part of Atlantis now the Sargasso Sea. A: As there were those individuals that attempted to bring again to the mind of man more of those forces that are manifest by the closer association of the mental and spiritual, or the soul forces that were more and more as individual and personal forms in the world, the use of the these elements —as for the building up, or the passage of individuals through space— brought the uses of the gases then (in the existent forces), and the individuals being able to become the elements, and *elementals* themselves, added to that used in the form of what is at present known as the raising of the powers from the sun itself, to the Ray that makes for disintegration of the atom, in the gaseous forces formed, and brought about the destruction in that portion of the land now presented, or represented, or called, Sargasso sea...

Q: Please give a few details regarding the physiognomy, habits, customs and costumes of the people of Atlantis during the period just before this first destruction. A: These, as we find, will require their being separated in the gradual development of the body and its physiognomy as it came into being in the various portions of that land, as well as to those that would separate themselves from those peoples where there were the indwelling of peoples, or man –as man, in the various areas of the land, or what we call world.

In the matter of form, as we find, first there were those as projections from that about the animal kingdom; for the "thought" bodies gradually took form, and the various combinations of the various forces that called or classified themselves as gods, or rulers over –whether herds, or fowls, or fishes, etc.– in part that kingdom and part of that as gradually evolved into a physiognomy much in the form of the present day (were one chosen of those... of the nearest representative of the race of peoples that existed in this first period as the first destructions came about).



These took on many sizes as to stature, from that as may be called the midget to the giants –for there were Giants in the Earth in those days, men as tall as (what would be termed today) ten to twelve feet in stature, and in proportion –well proportioned throughout. The ones that became the most useful were those as would be classified (or called in the present) as the ideal stature, that was of both male and female (as those separations had been begun); and the most ideal (as would be called) was Adam, who in that period... appeared as *five-in-one*. See?

In this the physiognomy was that of a full head, with an extra eye –as it were– in those portions that became what is known as the *third eye* [or pineal gland]. In the beginning these appeared in whatever portion was desired by the body for its use! As for the dress, those in the beginning were (and the Lord made for them coats) of the skins of the animals. These covered the parts of their person that had become, then, as those portions of their physiognomy that had brought much of the desires that made for destructive forces in their own experience; and these then were of those about them that were given as meat, or used as same –that partook of the herbs.

These were those same herbs that the seed were to have been for food for the man himself, and only those that partook of same may be called even clean –in the present day. Those that supply those same materials that are the proper building for the forces within the anatomical forces, or physiological forces, of a developing body; for these carry all the elements in their natural state. Little of minerals should ever be the properties within the system, save as may be taken through the vegetable forces, save where individuals have so laxed themselves as to require or need that which will make for an even balance of same.

Q: Does this (previous answer) mean that Jesus had been Adam? A: Study the Book which tells of him, Jesus, born of the Virgin Mary; (then) know this is the soul entity (Joshua) who reasoned with those who returned from captivity in those days when Nehemiah, Ezra, Zerubabel were factors in the attempts to re-establish the worship of God; and that (as) Joshua, the scribe, translated the rest of the books up to that time. Then realize (also) that is the same entity, who, as Joshua, as the mouthpiece of Moses, who gave the law: and was the same soul entity who, in those periods of the strength and yet weakness of Jacob in his love for Rachel, was their firstborn, Joseph.

[This soul also reincarnated] as Zend –father of the Zoroastrian religion– this is the same entity. And this entity was that one who had manifested to father Abraham as the prince, as Melchizedek, the priest of Salem, without father and without mother, without days or years, but a living human being in flesh, made manifest in the Earth from the desire of Father-God to prepare an escape for man; as was warned by the same entity, as Enoch; or, as in those days of Asapha, or Affa, in those periods when those of the Egyptian land were giving those counsels to the many nations, when there would be those saved of the physical from their own making (or doing) in the physical. Or, as the first begotten of the Father, who came as Amilius in the Atlantean land and allowed himself to be led into the ways of selfishness. And this was also the entity Adam –and this was the spirit of Light.

Such clear explanations from the Akashic Source were echoed in many other readings for this client, on the very same topic. Cayce's statements provide the specific identities of several prior reincarnations of the same high-level soul who incarnated as the Nazarene One in Aramaia. In these special readings, the Source includes Adam –the first modern human being– as the first human male¹⁴ incarnation of that soul, *as a projection of His Higher-Self*, a giant hermaphrodite of Atlantis named Amilius (Reading 364-3):

EC: Yes, we have the subject and those conditions. As has been said, much data has been received from time to time through psychic forces as respecting conditions in or through the period, or ages, of this continent's existence. That the continent existed is being proven as a fact.



Then, what took place during the period, or periods, when it was being broken up? What became of the inhabitants? What was the character of their civilization? Are there any evidences of those, or any portion of, the inhabitants' escape? The *position* of the continent, and the like, *must* be of interest to peoples in the present day, if either by inference that individuals are being born into the Earth plane to develop in the present, or are people being guided in their spiritual interpretation of individuals' lives or developments *by* the spirits of those who inhabited such a continent. In either case, if these be true, they *are wielding* –and are to wield– an influence upon the happenings of the present day world.

The position as the continent Atlantis occupied, is that as between the Gulf of Mexico on the one hand –and the Mediterranean upon the other. Evidences of this lost civilization are to be found in the Pyrenees and Morocco on the one hand, British Honduras, Yucatan and America upon the other. There are some protruding portions within this that must have at one time or another been a portion of this great continent. The British West Indies or the Bahamas, and a portion of same that may be seen in the present –if the geological survey would be made...– especially, or notably, in Bimini and in the Gulf Stream through this vicinity, these may be even yet determined.

What, then, is the character of the people? To give any proper conception, may we follow the line of a group, or an individual line, through this continent's existence –and gain from same something of their character, their physiognomy, and their spiritual and physical development.

In the period, then –some... 98,000 years before the entry of Ram into India [or 107,300 bp]– there lived in this land of Atlantis one Amilius, who had first *noted* that of the separations of the beings as inhabited that portion of the Earth's sphere or plane of those peoples into male and female as separate entities, or individuals. As to their forms in the physical sense, these were much *rather* of the nature of *thought forms*, or able to push out *of themselves* in that direction in which its development took shape in thought –much in the way and manner as the amoeba would in the waters of a stagnant bay, or lake, in the present.

As these took form, by the gratifying of their own desire for that as builded or added to the material conditions, they became hardened or set –much in the form of the existent human body of the day, with that of color as partook of its surroundings much in the manner as the chameleon in the present. Hence coming into that form as the red, or the mixture peoples –or colors; known then later by the associations as the *red* race.

These, then, able to use *in* their gradual development all the forces as were manifest in their individual surroundings, passing through those periods of developments as has been followed more closely in that of the yellow, the black, or the white races, in other portions of the world; yet with their immediate surroundings, with the facilities for the developments, these became much speedier in this particular portion of the globe than in others –and while the destruction of this continent and the peoples are far beyond any of that as has been kept as an absolute record, that record in the rocks still remains– as has that influence *of* those peoples in that life of those peoples to whom those that did escape during the periods of destruction make or influence the lives of those peoples *to* whom they came. As they *may* in the present, either through the direct influence of being regenerated, or reincarnated into the Earth, or through that of the *mental* application on through the influences as may be had upon thought *of* individuals or groups by speaking from that environ.

In the *manner* of living, in the manner of the moral, of the social, of the religious life of these peoples: There, classes existed much in the same order as existed among others; yet the like of the warlike *influence* did *not* exist in the peoples *–as* a people*–* as it did in the *other* portions of the universe.

In explaining the complex spiritual subjects, the Source has given great insights into the origins of the human species on Earth, if only the subtle use of language can be properly comprehended. The exact implications of Cayce's words are beyond the grasp of the average reader. Restated in basic terms, Amilius and Ai were Masters in Nature spiritually capable of *projecting themselves* as soul 'sub-units', thereby sub-dividing their soul units into separate reincarnation streams as the human male and female 'lower selves' Adam and Eve.

This highly advanced co-creative process of *spirit mitosis* was described by in a different way during a dialog with the Cassiopaeans, channeled by Laura Knight-Jadzcyk during a ouija session on February 25, 2023:

Q: (irjO) Can a soul or being, be still at 5th density contemplating [after death in pure spirit form], while at the same "time" part of its consciousness reincarnates and lives in one life or multiple ones? A: Yes

This same concept was given a century earlier through the Cayce readings as the actual origin of the modern human species on planet Earth. The Cassiopaeans also intimated transdimensional functions of the pyramid chambers involves an alteration of the atomic configuration of matter, during a November 2, 1994 session:

- Q: (L) Why did the Egyptians draw sideways? A: Atlantean method handed down. Simply artistic stylization.
- Q: (L) What about the passages in the pyramid. Why so odd? A: Used energy vortex for movement. Floated, levitated. Can still do this if you know how. In the pyramid the passages created the energy by their placement and relationship to other space/solid configurations. Passages sometimes changed their structure atomically and still do.
- Q: (L) What is the purpose of the Sarcophagus in the "Kings" chamber? A: Energy storage.
- Q: (L) Was there ever anything in this object? A: Yes... Many things.
- Q: (L) So, there was nothing permanent in it, you could put various things in it for various reasons? A: Yes.
- Q: (L) In our machinery we have dials and tuners, which adjust the machine to do a specific job or deliver a particular... flow of energy. What was the equivalent of dials and tuning devices in the pyramid? A: Thoughts.
- Q: (L) Was it the thoughts of a person in there or of a specific individual whose job it was to do this "thinking?" A: Both on occasion.
- Q: (L) Could just anybody go into the pyramid, get into this sarcophagus, and have something done to them as they specified? Or, was it the culmination of some other long process? A: All.
- Q: (L) When you say that the passages changed atomically, did you mean that they might actually become larger or smaller? A: Yes. And change position as well.

This reasoning explains the pyramids' unusually low passageways built without steps. Piezoelectric calcite and quartz crystals convert infrasound into high-intensity EM fields, exciting water vapor to form HHO plasma within chambers, the positions of which oscillate due to crystal lattice deformations (Reading 364-4):

EC: Yes, we have the subject here, the Lost Continent of Atlantis. As the peoples were a peaceful peoples, their developments took on rather that form –with the developing into the physical material bodies– of the fast development, or to the using of the elements about them to their own use; recognizing themselves to be a part of that about them. Hence, as to the supplying of that as necessary to sustain physical life as known today, in apparel, or supplying of the bodily needs, these were supplied through the natural elements; and the *developments* came rather in the forms –as would be termed in the *present* day– of preparing for those things that would pertain to what would be termed the aerial age, or the electrical age, and supplying then the modes and manners of transposition of those materials about same that did not pertain to themselves bodily; for of themselves was transposed, rather by that ability lying within each to be transposed in thought as in body.



In these things, then, did Amilius see the beginning of, and the abilities of, those of his own age, era, or period, not only able to build that as able to transpose or build up the elements about them but to transpose them bodily from one portion of the universe to the other, *through* the uses of not only those *recently* rediscovered gases, and those of the electrical and aeriatic formations –in the breaking up of the atomic forces to produce impelling force to those means and modes of transposition, or of travel, or of lifting large weights, or of changing the faces or forces of nature itself, but with these transpositions, with these changes that came in as personalities, we find these as the Sons of the Creative Force as manifest in their experience looking upon those changed forms, or the daughters of men, and there crept in those pollutions, of polluting themselves with those mixtures that brought contempt, hatred, bloodshed, and those that build for desires of self *without* respects of *others*' freedom, others' wishes –and there began, then, in the latter portion of this period of development, that that brought about those of dissenting and divisions among the peoples in the lands.

With the attempts of those still in power, through those lineages of the pure, that had kept themselves intact as of the abilities of forces as were manifest *in* their activities, these *builded* rather those things that *attempted* to draw *back* those peoples; through first the various changes or seasons that came about, and in the latter portion of the experience of Amilius was the first establishing of the altars upon which the sacrifices of the field and the forest, and those that were of that that *satisfied* the desires of the physical body, were builded.

With the continued disregard of those that were keeping the pure race and the pure peoples, of those that were to bring all these laws as applicable to the Sons of God, man brought in the destructive forces as used for the peoples that were to be the rule, that combined with those natural resources of the gases, of the electrical forces, made in nature and natural form the first of the eruptions that awoke from the depth of the slow cooling earth, and that portion now near what would be termed the Sargasso Sea first went into the depths.

With this there again came that egress of peoples that aided, or attempted to assume control, yet carrying with them *all* those forms of Amilius that he gained through that as for signs, for seasons, for days, for years. Hence we find in those various portions of the world even in the present day, some form of that as *was* presented by those peoples in *that* great *development* in this, the Eden of the world...

As we see the effects as builded in that about the sacred fires, as through those of Hermes [Ajax of Ode], those of Arart, those of the Aztec, those of Ohum [Aymara], each in their respective sphere *carrying* some portion of these blessings - when they are kept in accord and *pure* with those through which the channels of the blessings, of the Creative Forces, may manifest. So, we find, when we apply the lessons in the day –would ye be true, keep that *every whit* thou *knowest* to do within thine own heart! Knowing, as ye *use* that as is *known*, there is given the more and more light to know from whence ye came and whither ye go!...

Q: Please give a description of the Earth's surface as it existed at the time of Atlantis' highest civilization, using the names of continents, oceans and sections of same as we know them today? A: As to the highest point of civilization, this would first have to be determined according to the standard as to which it would be judged –as to whether the highest point was when Amilius ruled with those understandings, as the one that understood the variations, or whether they became man made, would depend upon whether we are viewing from a spiritual standpoint or upon that as a purely material or commercial standpoint; for the variations, as we find, extend over a period of some 200,000 years... and that there were *many* changes in the surface of what is now called the Earth.

In the first, or greater portion, we find that *now* known as the southern portions of South America and the Arctic or North Arctic regions, while those in what is *now* as Siberia –or that as of Hudson Bay– was rather in that region of the tropics, or that position now occupied by near what would be as the same *line* would run, of the southern Pacific, or central Pacific regions –and about the same way.

Then we find, with this change that came first in that portion, when the first of those peoples used that as prepared *for* the changes in the earth, we stood near the same position as the earth occupies in the present –as to Capricorn, or the equator, or the poles. Then, with that portion, *then* the South Pacific, or Lemuria, began its disappearance –even before Atlantis, for the changes were brought about in the latter portion of that period…or [of the] present setting of those, as set by Amilius –or Adam.

The characterization of Amilius as "one that understood the variations" is a veiled reference to the planetary atmospheric changes relates to the Galactic Wave Cycle of 309,833.33… years previously identified by this author in 2019.¹⁵ Highly advanced concepts discussed here by the Akashic Source were not readily comprehensible for the client, who continued with this important line of inquiry pertaining to subconscious influences related to his past life experiences during the time of Christ (Reading 364-5):

EC: Yes, we have the information as given respecting the continent Atlantis. In the considerations that may be had concerning such information, many are the questions that must naturally arise in the minds of individuals who would consider same in any way or manner. However, will a very close check be kept upon those who evince an interest, these will be found to be those who occupy in the present some influence innate or manifested from their experience or sojourn under or in that environ. As has been given, this would be well to do; for to the analytical or to the research character of mind, there will be little that may escape the attention of such a mind –when spiritual or psychic, or occult, or those kindred subjects are approached– as to how quick there is the desire, that expression of "I know it, but don't know how to explain it", will be in that individual's or entity's feeling, and expression –when one may be obtained at all. They will immediately become the dreamer! Try this!...

Q: Explain the information given regarding Amilius, who first noted the separation of the peoples into male and female, as it relates to the story in the Bible of Adam and Eve, in the Garden of Eden giving the name of the symbols Adam, Eve, the apple, and the serpent. A: This would require a whole period of a lecture period for this alone; for, as is seen, that as is given is the presentation of a teacher of a peoples that separated for that definite purpose of keeping alive in the minds, the hearts, the *soul* minds of entities, that there may be seen their closer relationship to the divine influences of Creative Forces, that brought into being all that appertains to man's indwelling as man in the form of flesh in this material world.

These are presented in symbols of that thought as held by those peoples from whom the physical recorder took those records as compiled, with that gained by himself in and through the entering into that state where the entity's soul mind drew upon the records that are made by the passing of time itself in a material world. As given, these are records not only of the nature as has been termed or called Akashic records (that is, of a mental or soul record), but that in a more material nature as set down in stone, that was attempted to be done *—has* been attempted to be done throughout *all* time! *Why* does man *now* set in stone those that are representatives of that desired to be kept in mind by those making records for future generations? There are many more materials more lasting, as is commonly known...

There are, as seen, the records made by the man in the mount, that this Amilius –Adam, as given– first discerned that from himself, not of the beasts about him, could be drawn –*was* drawn– that which made for the propagation *of* beings *in* the flesh, that made for that companionship as seen by creation in the material worlds about same. The story, the tale (if chosen to be called such), is one and the same. The apple, as 'the apple of the eye', the desire of that companionship innate in that created, as innate in the Creator, that brought companionship into the creation itself. Get that one!

In this there comes, then, that which is set before that created –or having *taken on* that form, able of projecting itself in *whatever* direction it chose to take, as given; able to make itself *of* that environ, in color, in harmony, in *whatever* source that makes for the spirit of that man would attempt to project in music, in art, in *any* form that may even be conceivable to the mind itself in what may be termed its most lucid moments, in its most esoteric moments, in its highest animation moments; for were He not the *Son* of the living God made manifest, that He might be the companion in a made world, in material manifested things, with the injunction to subdue all, *bring* all in the material things under subjection –all *under* subjection– by that ability to project itself *in* its way?



Knowing itself, as given, to be a portion *of* the whole, in, through, of, by the whole? In this desire, then, keep –as the injunction was– keep thine self separate: *of* that seen, but *not* that seen. The apple, then, that desire for that which made for the associations that bring carnal-minded influences of that brought as sex influence, known in a material world, and the partaking of same is that which brought the influence in the lives of that in the symbol of the serpent, that made for that which creates the desire that may be only satisfied in gratification of carnal forces, as partake of the world and its influences about same –rather than of the spiritual emanations from which it has its source. Will control –inability of will control, if we may put it in common parlance.

These decisive explanations from the Source are given in lengthy phrases that require rereading multiple times to fully grasp what has been conveyed. After providing the most important explanations, the Source often concludes long passages with quick tag-lines like "Get that one!" or "–See?" These subject endings implore the reader to fully reconsider all that has been given through this spectacular information channel.

The civilizing function of 81 Earthly incarnations projected by Amilius during this cycle included an "injunction to subdue all, *bring* all in the material things under subjection". Megafauna herds that threatened human life were subdued, allowing human analytical development to assert full control over the material environment. Pointed explanations continued to flow from Edgar Cayce in the following trance session (Reading 364-6):

EC: Yes, we have the information as written here, as given. In following out that as just given, with these changes coming in the experience of Amilius and Ai, Adam and Eve, the knowledge of their position, or that as is known in the material world today as desires and physical bodily charms, the understanding of sex, sex relationships, came into the experience. With these came the natural fear of that as had been forbidden, that they know themselves to be a part of but not *of* that as partook of *earthly*, or the desires in the manner as were *about* them, in that as had been their heritage.

Were this turned to that period when this desire, then, becomes consecrated in that accomplished again in the virgin body of the mother of the *Son* of man, we see this is then crystallized into that, that even that of the flesh may be –with the proper concept, proper desire in all its purity– consecrated to the *living* forces as manifest by the ability in that body so brought into being, as to make a way of escape for the *erring* man. Hence we have found throughout the ages, so oft the times when conception of truth became rampant with free-love, with the desecration of those things that brought to these in the beginning that of the *knowledge* of their existence, as to that that may be termed –and betimes became– the *moral*, or morality *of* a people.

Yet this same feeling, this same exaltation that comes from association of kindred bodies –that have their lives consecrated in a purposefulness, that makes for the ability of retaining those of the essence of creation in every virile body– can be made to become the fires that light truth, love, hope, patience, peace, harmony; for they are *ever* the key to those influences that fire the imaginations of those that are gifted in *any* form of depicting the high emotions of human experience, whether it be in the one or the other fields, and hence is judged by those that may not be able, or through desire submit themselves –as did Amilius and Ai to those *elements*, through the forces in the life as about them.



Which are *those elements* that emit *living forces*? Cayce's curious terms were not understood at that time, having only recently been revealed by this author as the vitalizing emissions of *radium* (Reading 364-7):

Q: How is the legend of Lilith connected with the period of Amilius? A: In the beginning, as was outlined, there was presented that that became as the Sons of God, in that male and female were as one, with those abilities for those changes as were able or capable of being brought about. In the changes that came from those *Things*, as were of the projections of the abilities of those entities to project, this as a being came as the companion; and when there was that turning to the within, through the sources of creation, as to make for the helpmeet of that as created by the first cause, or of the Creative Forces that brought into being that as was made, *then* –from out of self– was brought that as was to be the helpmeet, *not* just companion of the body. Hence the legend of the associations of the body during that period before there was brought into being the last of the creations, which was not of that that was *not* made, but the first of that that *was* made, and a helpmeet to the body, that there might be no change in the relationship of the *Sons* of God *with* those relationships of the sons and daughters of men.

In this then, also comes that as is held by many who have reached especially to that understanding of how *necessary*, then, becomes the *proper* mating of those souls that may be the *answers* one to another of that that may bring, through that association, that companionship, into being that that may be the more helpful, more sustaining, more the well-*rounded* life or experience of those that are a *portion* one of another. Do not misinterpret, but knowing that all are of one –yet there are those divisions that make for a *closer* union, when there are the proper relationships brought about. As an illustration, in this:

In the material world we find there is in the mineral kingdom those elements that are of the nature as to form a closer union one with another, and make as for compounds as make for elements that act more in unison with, or against, other forms of activity in the experience in the Earth's environ, or the earth's force, as makes for those active forces in the *elements* that are *about* the Earth. Such as we may find in those that make for the active forces in that of uranium, and that of ultramarine, and these make then for an element that becomes the more active force as with the abilities for the rates of emanation as may be thrown off from same.

So, as illustrated in the union, then, of –in the *physical* compounds– that as may vibrate, or make for emanations in the activities of their mental and spiritual, and material, or physical forces, as may make for a *greater* activity in this Earth environ. Then, there may be seen that as is in an elemental, or compound, that makes for that as is seen in the material experience as to become an antipathy for other elements that are as equally necessary in the experience of man's environ as in the combination of gases as may produce whenever combined that called water, and its antipathy for the elements in combustion is easily seen or known in man's experience.

So in those unions of that in the elemental forces of creative energies that take on the form of man, either in that of man or woman, with its *natural* or *elemental*, see? *Elemental* forces of its vibration, with the union of two that vibrate or respond to those vibrations in self, create for that ideal that becomes as that, in that created, in the form –as is known as radium, with its fast emittal vibrations, that brings for active forces, principles, that makes for such atomic forces within the active principles of all nature in its active force as to be one of the elemental bases from which life in its essence, as an active principle in a material world, has its sources, give off that which is *ever* good –unless abused, see?



So in that may there be basis for *those* forces, as *has* been, as *is* sought, thought, or *attained by* those who have, through the abilities of the vibrations, to make for a continued force in self as to meet, know, see, feel, understand, those sources from which such begets that of its kind, or as those that become as an antipathy for another, or as makes for those that makes for the variations in the tempering of the various elements, compounds, or the like; so, as is seen, *these* –then– form the *basis* for those things as has been given here, there, in their various ways and manners, as to the companion of, and *champions* of, that that first able –through its projection of itself and its abilities in the creation– to bring about that that was either of its *own* making, or creation, or that given in the beginning to *be* the force *through* which there might *be* that that would bring ever blessings, good, right, and love, in even the physical or material world. See?

Q: How long did it take for the division into male and female? A: That depends upon which, or what branch or *line* is considered. When there was brought into being that as of the projection of that created *by* that created, this took a period of evolutionary –or, as would be in the present year, fourscore and six year. That as brought into being as was of the creating *of* that that became a portion of, *of* that that was already created by the *Creator*, *that* brought into being as *were* those of the forces of nature itself. God said, "Let there be light" and there *was* light! God said, "Let there be life" and there *was* life!

Q: Were the thought forms that were able to push themselves out of themselves inhabited by souls, or were they of the animal kingdom? A: That as created by that *created*, of the animal kingdom. That created as by the Creator, with the soul.

Q: What was meant by the Sons of the Highest in Atlantis and the second coming of souls to the Earth, as mentioned in a life reading given thru this channel? A: In this period or age, as was seen –there is fault of words here to *project* that as actually *occurs* in the *formations* of that as comes about! There was, with the *will* of that as came into being through the correct channels, of that as created by the Creator, that of the *continuing* of the souls in its projection and [subsequent] projection –see?

While in that as was of the offspring, of that as pushed itself *into* form to *satisfy*, *gratify*, that of the desire of that known as carnal forces of the *sense*, of those created, there continued to be the war one with another, and there were then *-from* the other *sources* (worlds) the continuing entering of those that *would* make for the keeping of the balance, as of the first purpose of the Creative Forces, as it magnifies itself in that given sphere of activity, of that that had been *given* the *ability* to *create* with its *own* activity *-see*? And hence the second, or the *continued* entering of souls into that known as the Earth's plane during this period, for that activity as was brought about.

Let's *remember* that as was given, in the second, third from Adam, or fourth, or from Amilius, there was "In that day did they *call upon* the *name* of the Lord" –is right! And ever, when the elements that make for littleness, uncleanness, are crucified in the body, the *Spirit* of the Lord, of God, is present! When these are overbalanced, so that the body (physical), the mental man, the imagination of its heart, is evil, or his purpose is evil, then is that war continuing –as from the beginning.

Just the continued warring of those things within self as from the beginning; for with these changes as brought *sin* into the world, with same came the *fruits* of same, or the seed as of sin, which we see in the material world as those things that corrupt good ground, those that corrupt the elements that are of the compounds of those of the first causes, or elementals, and pests are seen –and the like, see? So does it follow throughout all creative forces, that the fruits of that as is active brings that seed that makes for the corrupting of, or the clearing of, in the activative forces of, that *being* acted upon.

Q: What was meant by "As in the first Adam sin entered, so in the last Adam all shall be made alive?" A: Adam's entry into the world in the beginning, then, must become the savior *of* the world, as it was committed to his care, "Be thou fruitful, multiply, and *subdue* the Earth!" Hence Amilius, Adam, the first Adam, the last Adam, becomes –then– that that is *given* the *power over* the earth, and –as in each soul the first to be conquered is self– then *all things*, conditions and elements, are subject unto that self!

That a universal law, as may be seen in that as may be demonstrated either in gases that destroy one another by becoming elements of the same, or that in the mineral or the animal kingdom as may be found that destroy, or *become* one *with* the other. Hence, as Adam given –the *Son* of God– so he *must* become that that would be able to take the world, the earth, back to that source from which it came, and *all power* is given in his keeping in the Earth, that he has overcome; self, death, hell and the grave even, become subservient unto Him *through* the conquering of self in that made flesh; for, as in the beginning was the word, the Word *was* with God, the Word *was* God, the same was *in* the beginning. The Word came and dwelt among men, the offspring of self in a material world, and the Word *overcame* the world –and hence the world *becomes*, then, as the servant of that that overcame the world!

Q: Please give the important re-incarnations of Adam in the world's history. A: In the beginning as Amilius, as Adam, as Melchizedek, as Zend [or Zoroaster], as Ur [or King Ur-Namma], as Asaph [musician of King David & Solomon]... –Joseph [son of Jacob] –Jesus [the Nazarene One].

Then, as that coming into the world in the second coming –for He will come again and receive His own, who have prepared themselves through that belief in Him and acting in that manner; for the *spirit* is abroad, and the time draws near, and there will be the reckoning of those even as in the first so in the last, and the last shall be first; for there is that Spirit abroad –He standeth near. He that hath eyes to see, let him see. He that hath ears to hear, let him hear that music of the coming of the Lord of this vineyard, and art *thou* ready to give account of that *thou* hast done with thine opportunity in the Earth as the Sons of God, as the heirs and joint heirs of glory *with* the Son?

Then make thine paths straight, for there must come an answering for that *thou* hast done with thine Lord! He will not tarry, for having overcome He shall appear even *as* the Lord *and* Master. Not as one born, but as one that returneth to His own, for He will walk and talk with men of every clime, and those that are faithful and just in their reckoning shall be caught up with Him to rule and to do *judgment* for a thousand years!

These powerful prophetic statements issued from the Akashic Source were quite specific, informing us that the time of the Master's return will be recognized after His knowledge has been disseminated to the world. By these means, He will overcome Satan's global control system and issue His judgment (Reading 364-8):

Q: Please explain what is meant by "He will walk and talk with men of every clime". Does this mean he will appear to many at once or appear to various peoples during a long period? A: As given, for a thousand years He will walk and talk with men of every clime. Then in groups, in masses, and then they shall reign of the first resurrection for a thousand years; for this will be when the changes materially come.

In the manner as He sat at the peace conference in Geneva, in the heart and soul of a man not reckoned by many as an even unusually Godly man; yet raised for a purpose, and he chose rather to be a channel of His thought for the world. So, as there has been, so will it be until the time as set. As was given of Him, not given to man to know the time or the period of the end, nor to man –save by their constituting themselves a channel through which He may speak. To be sure, man and woman alike; for, as given from the beginning, they are one. Not as man counts oneness from the material viewpoint. Rather from that as He gave, "Where are those thy persecutors?" "No man, Lord." "Neither do I condemn thee. Sin no more." In the searching out of those who, where and when He speaks, or has spoken among or with, or through men, "By their fruits ye shall know them."

They that bring more righteousness are the children of faith, hope, charity. These three; and they do so in *material* world, the Father, the Son, the Holy Spirit. Be thou, then, a channel that may oft walk with Him that gave not of else than, "Let not your hearts be troubled; neither let it be afraid. Let not thine right hand know what thy left hand doeth." Rather giving self to seeking, day by day, to *know* the will of the Father as was manifest in Him, and may be manifest in Thee, for He will not leave thee desolate, but will come to thee –but not unless invited; for, as in the periods, as we find, when He walked with men as the Master among men, or when as Joseph in the kingdoms that were raised as the saving of his peoples that *sold* him into bondage, or as the priest of Salem in the days when the call came that a peculiar peoples would proclaim his name, He has walked and talked with men.



Or, as in those days as Asapha, or [abbreviated as] Affa, in those periods when those of the Egyptian land were giving counsels to the many nations, when there would be that saving of the physical from that of their own making in the physical; or in the garden when those temptations came, or as the first begotten of the Father that came as Amilius in the Atlantean land and allowed himself to be led in ways of selfishness. Hence, as we see, all the various stages of developments that have come to man through the ages have been those periods when He walked and talked with man.

In this, then, when –as we find– that those periods began in a like period from that of Joseph to... Jesus, then again we see the cycle when perfected in body, overcoming the world in the body of man, will He appear in those *varied* experiences; for He tarries not, and the time draws near.

Q: In the Persian experience as San (or Zend) did Jesus give the basic teachings of what became Zoroastrianism? A: In all those periods that the basic principle was the Oneness of the Father, He has walked with men.

The clarity of information provided by the Source speaking through Cayce was stunningly consistent over many years of interrogation on the same spiritual subject of Christ Consciousness (Reading 262-60):

Q: In Atlantis, was I associated with Amilius? If so, how? A: One as projected by that entity as to a ruler or *guide* for many, with its associating entity.

Q: (Continuing) [Was this entity] contained in the one body Zan during that period, or was it separated? A: [This question was] not asked correctly! These were all together in Amilius. They were material bodies as came in Adam. They were as associated in body as came in Zan [aka Zend], or that that eventually became through its incarnations into the Earth, those forces as the Savior in all periods.

Q: In canonizing the Bible, why was the life of Zan left out? A: Called by other names. For, much might be given respecting that ye have that ye call the Bible. This has passed through many hands. Many that would turn that which was written into the meanings that would suit their own purposes, as ye yourselves often do. But if ye will get the spirit of that written there ye may find it will lead thee to the gates of heaven. For, it tells of God, of your home, of His dealings with His peoples in many environs, in many lands. Read it to be wise. Study it to understand. *Live* it to know that the Christ walks through same with thee. For, as He gave, in righteousness may ye know those things that have been preserved from the foundations of the world in thine own experience. For, these are told there in the manners of those that recorded same in their own environ. What wilt *thou* write today that will be as the words of life to thy brothers in the ages to come? For, He has given, ye have been called –and have a work to do.



Then, in the next lesson ye shall have, shall much be given concerning how that which is carnal and that which is mental and that which is spiritual may be found –in *desire*. For, it builds –and is that which is the basis of evolution, and of life, and of truth. It also takes hold on hell and paves the way for many that find themselves oft therein. In spirit, in body, in mind. The message, then, that ye would study in this, should be: "Father, let thy desires be my desires. Let my desires, God, be thy desires, in Spirit and in Truth".

Similar sentiments emerged during another Life Reading given on January 5, 1941 (Reading 281-51):

Also it has been and is hard for individuals to conceive of Adam sinning in a material world, –as a man, a son, made by the hands of God... Few can conceive of the body through which the Prince of Peace manifested –the Son, the first and the last Adam– as having been a channel for material desire, when considered as a body so purified as to bear that perfect One.

Here, the Source gives an indirect yet significant reference to Hermes being that elevated incarnation of the Master who appeared in Egypt during the reconstruction period immediately following the 2nd destruction of Atlantis, known to us today as the Great Flood that occurred at ~30,220 bp (Reading 281-10):

- Q: Have I ever been associated with the Master? If so, when and where? A: In Egypt.
- Q: What time, or what period was this that the Master was in Egypt? A: When the entity was there!
- Q: Who was the Master at that time? A: The Master of men at that time!...

Q: Was this during the period of the banishment of the priest Ra-Ta? A: In the rebuilding period [30,200 years ago], that has been given. The association then that made for the building up of that consciousness of the laying aside of the various forces, or sources, that in the present find themselves as attributes of the mental, or the sensations or imaginative forces of the body.

Karmic dynamics of the Healing Group readings given by Cayce were also addressed (Woodward, 1987):

From inferences in Reading 281-10 (A-18 through A-23) and others from time to time, it seemed to be implied that Jesus had had an incarnation in Egypt under the name of Hermes. At that time Edgar Cayce, then Ra-Ta the priest, had been seeking to rebuild the spiritual life of that country. One member of the Healing Group, No. 69, was told that she had been associated with "the Master of Men" then (281-10, A-21) and that this association was one "that made for the building up of that consciousness of the laying aside of the various forces, or sources, that in the present find themselves as attributes of the mental, or the sensations or imaginative forces of the body" (281-10, A-27). It was also brought out that members of this group had worked together before for just such a purpose (281-1). Also, we recall that in Reading 294-127 these individuals were characterized as "these who were with Him." So it seems possible that the Master (then Hermes, later Jesus) was guiding these persons in healing work some [30,000] years ago. Again they had been called to this vitally important service...

Q: What is meant by the day of the Lord is near at hand? A: That –as has been promised through the prophets and the sages of old– the time, and half-time, has been and is being fulfilled in this day and generation; and that soon there will again appear in the earth that one through whom many will be called to meet those who are preparing the way for His day in the earth. The Lord then will come, even as ye have seen Him go... when those who are His have made the way clear and passable for Him to come. (262-49)...

In the very first reading, 281-1, Edgar Cayce in a preliminary explanation seemed to imply that different members had had close association with other members, which brought karmic situations to be worked out together, especially if these associations had been "the last experience." He added, however, that there had been "those experiences with the group as a whole where the greater portion have worked together for the common good of all." These had resulted in "contacts where there was healing brought in their individual experience with the divine forces manifested in a material world." The group "as a whole" was to be assisted in its "dispensing of an ideal" by being able to call on the services of Edgar Cayce, through whom "sources of information" could be given each to "assist and aid in all phases of their experience." The individual members fitting themselves "to be a manifestation of His love in this particular experience" would "lose self in love and service to others."

Judging from this explanation and the preceding references, it would seem to us that there is a striking parallel between the age of Ra-Ta and the present. Just as Hermes had had a spiritual climate provided by Ra-Ta, the priest, from which to draw individuals to work with him in the old Egyptian era [of Ra], again some of those interested in Edgar Cayce's work today would be used by the Master to serve their fellows. Surely the Master thus uses sincere seekers in any group which tries to alleviate the ills of mankind. The psychic ability of Edgar Cayce was to be utilized in bringing to these individuals helpful information and advice.¹⁶

This is a direct reference to the actions of genuine Christian leaders in our world today who now stand in unified opposition to the Nazi/CIA New World Order 'plandemic' control system. Russian President Vladimir Putin delivered unequivocal statements in March, 2020 condemning Satanic policies of the US and Europe:

I'm tired today –tired of everything. I want to talk to countries of the world. What's happening? What kind of Satanic plan do you dream of? You want to deliberately reduce the world's population by sacrificing innocent lives using unstable spirits who believe in your political correctness? Brainwashing people; vicious media systems and shameless lies –constantly and intentionally.

I'm aware of your Satanic plans to reduce the population of the planet. You are so evil to use the weakest and marginalized. If you think your people will have to get used to being massacred, leave your position! America and Europe, if you do not end these plans, you will face not only the wrath of God, but mine as well. Long live God and the Fatherland –or death is waiting for you.

Strategic resistance to the global tyranny of Satanism rising in the world today is seeded by Donald Trump, Vladimir Putin, Xi Jinping and Benjamin Netanyahu, among many other conscientious world leaders. This group is orchestrating the 'clearing of the way' for the return of the Master spoken of by Cayce in 1933, by effectively removing the control mechanisms that have been installed by Satan's minions long before the Dynastic Egyptian Period. During the preceding high civilization, Satan was known as 'Belial' or 'Baal'.

As given in the Book of Enoch, the reincarnation of the man known as 'Jesus' during the end times will be the Son of Man who will appear from among the people, to be recognized by those with knowledge and wisdom. The dissemination of His knowledge will revitalize the spiritual aspirations of all innately spiritual people on Earth; for those who make serious efforts to comprehend their relationship to the Creator.

Definitive explanations offered through Edgar Cayce's trance readings reveal the unity of spiritual teachings offered through ancient religions, describing the transformation of Amilius into Adam; of Brahma into Bokar:

He chose to materialize Himself in the lower realm of increasingly dense matter –His second creation– where the light must be shared with darkness, on planet Earth. But why? For a divine purpose, the records suggest. A purpose sacrificial in nature. Appearing again and again in physical manifestation, at the very last His cycle of earthly appearances ended in victory on a cross and in a grave. He arose, and returned from whence He came, that others in the Earth might follow.

"Study the philosophical or theosophical data," Cayce once advised a woman who approached him as to how she should go about getting involved in spiritual work that would be complementary to his own. On yet another occasion, one of Cayce's psychic readings made reference to the useful role played in the development of the mind of man by the philosophy presented to the world by Confucius and Buddha, or contained in the teachings of Taoism, as well as in those sacred scriptures of India that tell of Brahma. He then went on to emphasize the need to correlate the scriptures of various lands, down through the ages, as a means of expanding our spiritual perspective in line with that holistic precept to be found in the Bible: "The Lord thy God is One"...



So we turn to the Hindu literature. Here, too, there are variations, [yet] we find God identified in the beginning as Brahma, the Absolute Being. Yet he is also billed as the creative member (the Mind-force, as it were) of the Hindu version of the trinity, whose "mind-born sons" make their appearance, along with the *saptarishi* –angelic agents– in the first, or invisible, creation. Later, moving out from the interior realm of the Absolute Self, Brahma initiates the "cycle of necessity" by dropping the Cosmic Egg into chaos, from which the visible universe is hatched into being. Then, as Lord of the universe, Brahma enters this lower creation in bodily form to commence the Grand Cycle of evolution back to the Absolute, and to show to the struggling souls around Him the path of liberation from the treadmill of karma, rebirth, and maya –the illusion of separation and multiplicity.

In the Bhagavad-gita, a popular Vedic text, we find this embodiment of the Higher Self referred to as the Atman. Commentaries on the Gita, however, make it clear that we should regard the Atman merely as another name and form for Brahman, or Brahma... In Cayce's psychic interpretation of the biblical version of events, we discover the Lord playing out His divine role as Wayshower through some thirty different incarnations in the flesh, always under different names, but ever the Christ... Conceivably, though, one of them may have been an incarnation in ancient India, under the Brahmanic name. For the Cayce readings tell us that the biblical "Savior," whether in fleshly manifestation himself, or appearing as that invisible Christ impulse directing others in tune with the one Universal Consciousness, has influenced all those forms of philosophy or religious thought throughout history which have taught that God is One. In any event, we may readily imagine Him as the Teacher of the Vedic cosmogony and philosophy, who upon His passage from their midst was subsequently deified and mythologized by reverential Hindu scribes, who had glimpsed His divinity. It is a plausible scenario... [which] would certainly explain, as nothing else can, why two of the world's leading religions, so distinctly separate in cultural and geographic terms, nonetheless offer an account of creation so remarkably similar.



And there is yet another aspect of their parallelism for us to ponder: the Word. OM. In the Hindu lexicon, "OM" is the vibratory sound and symbol of Brahma. It is also referred to as the "Audible Life Stream," an occult term that may be equated, in essence, with the Voice of Creation - the Word. (Sound, like light, we are reminded, is merely a mode of energy or vibration.) Repeated over and over during the act of meditation, OM (pronounced "Aum" or "Ohm") is the traditional Hindu mantra. Its audible repetition is believed to raise the bodily vibrations in such a manner as to rouse the sleeping kundalini energy resting like a coiled serpent at the base of the spine, as the meditator moves into an altered state of consciousness.

Once awakened, this transforming "energy" is said to dart upward through the body along a prescribed path, activating certain spiritual centers until it may reach the highest of these, which has an esoteric association with the pituitary gland at the center of the brain. If this pinnacle is reached, a blissful condition of Oneness with Brahma, or God, is supposedly experienced by the meditator. This exalted state of being is termed Samadhi [meaning "Universal delivering"]. It is comparable, of course, to the "rapture" of Christian saints and mystics, who have achieved a condition of meditative union with God through the raising of the Christ Consciousness within –an identical transformation process, obviously, but simply under different metaphorical terms of reference. In psychological language, this same meditative state has been called "cosmic consciousness."17

Cosmic consciousness is the elevated goal of Siddha alchemy practices, applying highly advanced principles of atomic biophysics for enhancing biophotonic functions of the human body within HHO plasma chambers. In another Life Reading, a client was informed that he had lived a past life as a 'thought projection' entity who took on the physical form of a giant hermaphrodite living on the continent of Atlantis (Reading 5056-1):

Entity was in the Atlantean land and in those periods before Adam was in the Earth. The entity was among those who were then "thought projections", and the physical being had the union of sex in the one body, and yet a real musician on pipes or reed instruments.

This unusual concept was expanded upon in a series of readings for a different client (Reading 364-12):

As those people that were projections upon this plane of man's making began to multiply, and to attach themselves to the various activities that were necessary for self-preservation and propagation, and developed concepts of self, the ego, the "I Am", they began to seek gratification of those forces manifest in their material beings; desire for amusement, desire for the preserving of thoughts (records of their material involvement), rather than towards their continued associations with the Source. The "its", now, is the man!

The concept of using the pronoun "it" to refer to a more advanced 'neuter' gender also emerged in the 1987 Thiaoouba ET contact case of Michel Desmarquet.¹⁸ Such unusual humanoid biology subjects were not comprehensible at the time they were given. Several decades of scientific progress has broadened our perceptive capacity, preparing the way for Atlantean souls now reincarnating as teachers (Reading 5748-5):

EC: Yes. In the information as respecting the pyramids, their purpose in the experience of the peoples, in the period when there was the rebuilding of the priest during the return in the land, some 28,000 years before the coming of the Christ into the land, there was first that attempt to restore and to add to that which had been begun on what is called the Sphinx, and the treasure or storehouse facing same, between this and the Nile, in which those records were kept by Arart and Araaraart in the period.

Then, with Hermes and Ra (those that assumed or took up the work of Araaraart) there began the building of that now called [the] Giza [Plateau in Egypt], with which those prophecies that had been in the Temple of Records and the Temple Beautiful were builded, in the building of this that was to be the hall of the initiates of that sometimes referred to as the White Brotherhood.

This, then, receives all the records from the beginnings of that given by the priest, Arart, Araaraart and Ra, to that period when there is to be the change in the Earth's position and the return of the Great Initiate to that and other lands for the folding up of those prophecies that are depicted there. All changes that came in the religious thought in the world are shown there, in the variations in which the passage through same is reached, from the base to the top or to the open tomb *and* the top. These are signified by both the layer and the color in what direction the turn is made.

This, then, is the purpose for the record and the meaning to be interpreted by those that have come and do come as the teachers in various periods, in the experience of this present... activity of the [various regions] of the Earth.

The 'Great Initiate' is a direct reference to the return of the Master who had previously reincarnated in Atlantis as Ajax (also called Ax-Tell and Hermes) and in Judea as the Nazarene One (Reading 5748-6):

EC: Much has been written respecting that represented in the Great Pyramid, and the record that may be read by those who would seek to know more concerning the relationships that have existed, that may exist, that do exist, between those of the Creative Forces that are manifest in the material world. As indicated, there were periods when a much closer relationship existed, or rather should it be said, there was a much better understanding *of* the relationship that *exists* between the creature and the Creator.

In those conditions that are signified in the way through the pyramid, as of periods through which the world has passed and is passing, as related to the religious or the spiritual experiences of man –the period of the present is represented by the low passage or depression showing a downward tendency, as indicated by the variations in the character of stone used. This might be termed in the present as the Cruciatarian Age, or that in which preparations are being made for the beginning of a new sub-race, or a change, which –as indicated from the astronomical or numerical conditions– dates from the latter portion or middle portion of the present fall [of 1932]. In October there will be a period in which the benevolent influences of Jupiter and Uranus will be stronger, which –from an astrological viewpoint– will bring a greater interest in occult or mystic influences.

At the correct time accurate imaginary lines can be drawn from the opening of the great Pyramid to the second star in the Great Dipper, called Polaris or the North Star. This indicates it is the system toward which the soul takes it flight after having completed its sojourn through this solar system. In October there will be seen the first variation in the position of the polar star in relation to the lines from the Great Pyramid. The dipper is gradually changing, and when this change becomes noticeable –as might be calculated from the Pyramid– there will be the beginning of the change in the races. There will come a greater influx of souls from the Atlantean, Lemurian, La, Ur or Da civilizations. These conditions are indicated in this turn in the journey through the pyramid.

How was this begun? Who was given that this should be a record of man's experiences in this root race? For that is the period covered by the prophecies in the pyramid. This was given to Ra and Hermes in that period during the reign of Araaraart when there were many who sought to bring to man a better understanding of the close relationship between the Creative Forces and that created, between man and man, and man and his Maker.

Only those who have been called may truly understand. Who then has been called? Whosoever will make himself a channel may be raised to that of a blessing that is all that entity-body is able to comprehend. Who, having his whole measure full, would desire more does so to his own undoing...

Q: What was the date of the actual beginning and ending of the construction of the Great Pyramid? A: Was one hundred years in construction. Begun and completed in the period of Araaraart's time, with Hermes and Ra...

Q: What definite details are indicated as to what will happen after we enter the period of the King's Chamber? A: When the bridegroom is at hand, all do rejoice. When we enter that understanding of being in the King's presence, with that of the mental seeking, the joy, the buoyancy, the new understanding [of the relationship between humanity and the Creator], the new life, through the period.

Q: What is the significance of the empty sarcophagus? A: That there will be no more death. Don't misunderstand or misinterpret! [It is] but the *interpretation* of death will be made plain.

Q: If the Armageddon is foretold in the Great Pyramid, please give a description of it and the date of its beginning and ending. A: Not in what is left there. It will be as a thousand years, with the fighting in the air, and –as has been– between those returning to and those leaving the Earth…



Q: How was this particular Great Pyramid of Gizeh built? A: By the use of those forces in nature as make for iron to swim. Stone floats in the air in the same manner. This will be discovered in '58 [as an effect of high-intensity ultrasound waves].

Q: What is the significance of the character of the figure of the Sphinx, mentioned above? A: In this particular period of Araaraart and of the priest (that began those understandings –and passed through those of the hell in the misinterpretation of same), there was even then the seeking through those channels that are today called archaeological research.

In those periods when the first change had come in the position of the land, there had been an egress of peoples –or *Things*, as would be called today– from the Atlantean land, when the Nile (of Nole, then) emptied into what is now the Atlantic Ocean, on the Congo end of the country. What is now as the Sahara was a fertile land, a city that was builded in the edge of the land, a city of those that worshipped the sun –for the use of its rays were used for supplying from the elements that which is required in the present to be grown through a season; or the abilities to use both those of introgression and retrogression– and mostly retrograded, as we are in the present. The beginnings of these mounds were as an interpretation of that which was crustating in the land. (See, most of the people had tails then!) In those beginnings these were left.

When there was the entrance of Arart and Araaraart, they begin to build upon those mounds which were discovered through research. With the storehouse, or record house (where the records are still to be uncovered), there is a chamber or passage from the right forepaw to this entrance of the record chamber, or record tomb. This may not be entered without an understanding, for those that were left as guards may *not* be passed until after a period of their regeneration in the mount, or the fifth root race begins.

In the building of the pyramid, and that which is now called the Mystery of Mysteries, this was intended to be a *memorial* –as would be termed today– to that counsellor who ruled or governed, or who acted in the capacity of the director in the *material* things in the land. With the return of the priest (as it had been stopped), this was later –by Isis, the queen, or the daughter of Ra– turned so as to present to those peoples in that land the relationships of man and the animal or carnal world with those changes that fade or fall away in their various effect.

These may be seen in a different manner presented in many of the various sphinxes, as called, in other portions of the land –as the lion with the man, the various forms of wing, or characterizations in their various developments. These were as presentations of those projections that had been handed down in their various developments of that which becomes man –as in the present.

The explanations of Cayce reflect the highly specialized Atlantean cultural context of psychoacoustic natal practices facilitated by the global network of pyramids and megalithic temples. The unification of global society was promoted during those periods by guidance from the Sons of the Law of One¹⁹ (Reading 790-1):



Before that we find the entity was in that land now known as the Egyptian, during those periods when there were those coming in from the Atlantean land, and when there began the buildings for the preservations of those things that may yet come to light as those activities of the study of the Law of One.

The entity then, as would be termed today, was a supervisor for the inlaying of the stones, the inlaying for the tombs. And the pyramids should be of special interest to the entity; for some chambers –that are still represented– were the *individual* understandings or activities of the entity in relationships to Ra, Ra-Ta, Hermes, and the activities of Isis and those peoples that made for the preservings in that particular period of activity.

Specific activities that made for the 'preservings' in that period is an indirect reference to the sophisticated use of long-lived radio-isotopes such as Ra²²⁶ and Mc²⁹⁶ applied by Atlantean alchemists after Hermes for preventing decomposition of both living and dead body tissues, and all related microbial activity. Controlled application of atomic forces within the human body propelled the advancement of human consciousness and a resulting increase in average human longevity during that elevated cultural period (Reading 294-151):

Then began what may be truly termed the first national or nation *spirit* of a peoples; for with the divisions, rather than this causing a dispersing of ideals or a dividing up of interests, it *centralized* the interests; for these were being guided by a ruler or king whose authority was not questioned any more, nor were the advisings of the priest questioned, who was acting in rather the capacity of preparing for this very spirit to manifest itself in the way of the national emblems, the national ideas, that stood for the varied activities of not only individuals or groups, but for the general masses. Hence there began the first preparation for what has later become that called the Great Pyramid, that was to be the presentation of that which had been gained by these peoples through the activities of Ra-Ta, who *now* was known as Ra.

For with the entering in of Hermes *with* Ra –who came as one of the peoples from the mount to which these peoples had been banished and the raising of that one who had been condemned with the priest in banishment to one that was to be without question the queen, or the advisor to all of her own peoples, there was brought the idea of the preservation of these, not only for those in the present but for the generations that were to come in the experiences and experiences throughout that period, until the changes were to come again in the earth's position that would make for, as it had in this inundation that brought about Ra-Ta's coming in the experience from the gods in the Caspian and the Caucasian mountains, that had brought this change in the peoples.

Hence under the authority of Ra, and Hermes as the guide, or the actual (as would be termed in the present) constructing or construction architect with the priest or Ra giving the directions –and those of Isis (now) in the form of the advisor for the laying in of those things that would present to those peoples the *advancement* of the portion of man, or woman, to her position in the activities of the human race or human experience, these changed the position or attitude of these particular peoples as to the position that was held by woman in her relations to the developing of the conditions that either were to be national, local, or individual; for not only does this become then that upon which man depends for those advancements or advents into the material activities, but the nourishing of, the maintaining of, that to which its (the man's) ideals are to be turned in their activity when they arise at that period when expressions are to be given to the active forces in the material activities.

This, then, made for an *endowing* of this body... Isis, to the position of the first goddess that was so crowned, and there was given then that place that was to be sought by others that would gain counsel and advice even from the priest, gained access through that of Isis to the Throne itself. Not that it rose above the authority of the king, but for that developing necessary for the activities of the woman in those spheres of activity in this particular development.

Then began the laying out of the pyramid and the building of same, the using of those forces that made for the activity of bringing then from those very mountains where there had been those places of refuge that which had been begun to establish these, not only into that which would remain as the place for receiving that which had been offered in the Temple Beautiful on the various altars of the activities of an individual's innate self, but to be the place of initiation of the initiates that were to act in the capacity of leaders in the various activities through this period.

This building, as we find, lasted for a period of what is termed now as one hundred years. It was formed according to that which had been worked out by Ra-Ta in the mount as related to the position of the various stars, that acted in the place about which this particular solar system circles in its activity, going towards what? That same name as to which the priest was banished –the constellation of Libra, or to Libya were these people sent. Is it not fitting, then, that these must return as this priest may develop himself to be in that position, to be in the capacity of a *liberator* of the world in its relationships to individuals in those periods to come; for he must enter again at that period, or in 1998.

Explanations such as these reiterate a core concept given by Cayce regarding soul-group dynamics; that the course of the 20th century witnessed increasing reincarnations of individuals with prior lives as Atlantean Sons of the Law of One, who resonate today with the teachings of Christ Consciousness (Reading 884-1):

Being among the princesses of him that made for the rulings over the land at the time, in the name Ahasus, the entity made for that of bringing to her own peoples the greater understandings, and especially those that had followed in the way of the Law of One –or that manifested in the present as the Christ Consciousness, or the sons of Adam that had joined themselves with the sons of God, and as the sons of Adam that –with Amilius– had made the records of those things whereby there might be the cleansing of the body from the pollutions of the world, or of the animal kingdom.

Prophetic statements from Cayce indicate an upcoming announcement of the discovery of Paleo-Sanskrit tablet texts recording advanced biophotonic healing procedures applied at Atlantean temples for genetic purification and physical regeneration, reflecting the Master's teachings on the Fire of Life (Reading 3054-4):

First find thyself. Apply thyself in such a way and manner as to know what ye will do with this man, Jesus of Nazareth –Jeshua of Jerusalem, Joshua in Shiloh, Joseph in the court of Pharaoh, Melchizedek as he blessed Abraham, Enoch as he warned the people, Adam as he listened to Eve.

Here the Akashic Source implores our own mental and spiritual preparation for the ascension of Earth in the light of high knowledge. We are asked to contemplate whether we are truly ready for this next step in the evolution of consciousness on this planet. In a Life Reading for Nikola Tesla, Cayce gave similar advice: "Yea –in those days– when His forerunner may come into the Earth for preparing the place for the Son of Man, that His kingdom may be established in the Earth, wilt thou be ready? Seek ye Him." (Reading 487-17)²⁰

The prescient trance readings of Edgar Cayce lay out the grand design of the origins of humanity in great detail, revealing the origin of the first Adam as a soul projection of Amilius, and the destiny of the last Adam to elevate humanity on Earth by restoring high knowledge of the Fire of Life and the proper use of metals.

A thorough review of astounding evidence identified in decades of Biblical archeology research conducted by Ron Wyatt –from Noah's Ark in Dogubeyazit, Turkey, scuba-diving the Red Sea crossing site, documenting Mount Sinai, the ruins of Sodom and Gommorah, the Crucifixion Temple and Ark of the Covenant– confirms the participation of an invisible spiritual element working through his especially attuned consciousness.

Subconscious urges that drove the willful, determined spirit of Ron Wyatt's research find their source in the experiences of previous lifetimes that were directly involved with major political events recorded in ancient historical documents from Judea and Egypt, especially the Bible. What was the identity of that previous lifetime that could account for his intuitive knowledge of these ancient sites and their great significance?



Of all the guidance and protection Ron had received from the 4 Guardian Angels, *why was he instructed to make a video recording of himself removing the pair of sacred stone tablets from the Ark of the Covenant?*

Ron Wyatt was the reincarnation of Moses, who completed the life's work of Moses by removing the Ten Commandments from the Ark while the 4 Guardian Angels lifted the mercy seat for him to gain access. These deceptions include dissemination of false information regarding the mythical druid Merlin, to obfuscate the direct connection between the legends of King Arthur and actual events that took place at the Crucifixion Temple built by Joseph of Arimathea with other disciples of Jesus.
